The Brentwood (Parishes) Order 1983

<i>Made</i> 2	2nd December 1983
Coming into Operation—	
for the purposes described in article 2(1)	1st January 1984
for all other purposes	1st April 1984

Whereas the District Council of Brentwood, acting pursuant to section 48(8) of the Local Government Act 1972(a), has made recommendations to the Local Government Boundary Commission for England for proposals about parishes in the district:

And whereas the said Commission has seen fit, pursuant to sections 47, 48(9) and 51(1) of that Act, on 9th March 1982, to make the recommended proposals, with modifications, to the Secretary of State:

And whereas the Secretary of State has decided to give effect to those modified proposals without further modifications:

Now, therefore, the Secretary of State for the Environment, in exercise of his powers under section 51(2) and 67(4) and (5) of the said Act and of all other powers enabling him in that behalf, hereby makes the following order:—

Title and commencement

1. This order may be cited as the Brentwood (Parishes) Order 1983.

2.— (1) 1st January 1984 is hereby specified as the day on which this order shall come into operation for any purpose set out in regulation 4(1) (coming into operation of order) of the Local Government Area Changes Regulations 1976(b)

(2) For all other purposes this order shall come into operation on 1st April 1984.

Changes in areas

3.—(1) That part of the parish of Doddinghurst which is marked Al on the map issued by the Department of the Environment and entitled "Map of the Brentwood (Parishes) Order 1983" shall be transferred to the parish of Kelvedon Hatch.

(2) That part of the parish of Kelvedon Hatch which is marked A2 on the map mentioned in paragraph (1) shall be transferred to the parish of Stondon Massey.

District wards

4.— (1) The Brizes and Doddinghurst wards of the district of Brentwood shall be abolished.

(2) A new ward of that district, to be known as the Brizes and Doddinghurst ward shall be formed, comprising the areas of the parishes of Doddinghurst, Kelvedon Hatch, Navestock and Stondon Massey as at 1st April 1984. There shall be 3 councillors for the new ward.

(3) In consequence of paragraphs (1) and (2), the District of Brentwood (Electoral Arrangements) Order 1975(a) shall be amended so that—

- (i) in article 10(1), for "Blackmore, Doddinghurst and Hook End and Wyatts Green wards of the district", there shall be substituted "Blackmore and Hook End and Wyatts Green wards of the district or for the parish of Doddinghurst"; and
- (ii) in Schedule 1 and 2, for the entries relating to Brizes and Doddinghurst wards there shall be substituted---

"Brizes and Doddinghurst 3" and "Brizes and Doddinghurst 1 1 1" respectively.

Parish council of Kelvedon Hatch

5.—(1) As from 7th May 1984, the number of councillors for the parish of Kelvedon Hatch shall be 11.

(2) All parish councillors for that parish in office immediately before 1st April 1984 shall continue in office until 7th May 1984, on which day they shall retire. Any casual vacancy in their number which exists on, or occurs before, 1st April 1984 shall not be filled unless notice of an election to fill it has been given before that day.

(3) New parish councillors shall be elected on 3rd May 1984. They shall come into office on 7th May 1984 and shall retire on the fourth day after the ordinary day of election of parish councillors in 1987.

District councillors

6.— (1) Any person in office immediately before 1st April 1984 as district councillor for the Brizes or Doddinghurst ward of the district of Brentwood shall represent the Brizes and Doddinghurst ward until 7th May 1984, on which day he shall retire. Any casual vacancy in that office which exists on, or occurs before 1st April 1984 shall not be filled unless notice of an election to fill it has been given before that day.

(2) District councillors for the new ward shall be elected on 3rd May 1984, and shall retire in accordance with the procedure specified in article 9 of the District of Brentwood (Electoral Arrangements) Order 1975.


EXPLANATORY NOTE
