The Gaming Act (Variation of Monetary Limits) (Scotland) Order 1983

Made	21st December 1983
Laid before Parliament	11th January 1984
Coming into Operation	6th February 1984

In exercise of the powers conferred on me by sections 34(9) and 51(4) of the Gaming Act 1968(a), and of all other powers enabling me in that behalf, I hereby make the following Order:—

1.—(1) This order may be cited as the Gaming Act (Variation of Monetary Limits) (Scotland) Order 1983 and shall come into operation on 6th February 1984.

(2) This order shall extend to Scotland only.

2. The provisions of section 34 of the Gaming Act 1968 specified in column 1 of the Schedule to this order (which relate to maximum sums permitted in respect of the matters mentioned in column 2 of that Schedule) shall have effect as if for the references in those provisions to the sums specified in column 3 of that Schedule (which were substituted by the Gaming Act (Variation of Monetary Limits) (Scotland) Order 1981(b)), there were substituted references to the sums specified in column 4 thereof, respectively.

3. In the Schedule to the Gaming Act (Variation of Monetary Limits) (Scotland) Order 1981 the entries relating to subsections (3), (4) and (8) of section 34 of the Gaming Act 1968 are hereby revoked.
