**1983 No. 373****INDUSTRIAL ASSURANCE****The Industrial Assurance (Fees) Regulations 1983**

The Industrial Assurance Commissioner, with the approval of the Treasury, in exercise of the powers conferred upon him by section 43 of the Industrial Assurance Act 1923 (a) and of all other powers enabling him in that behalf, hereby makes the following Regulations:—

1. These Regulations may be cited as the Industrial Assurance (Fees) Regulations 1983 and shall come into operation on 1st April 1983.
2. In the Regulations “the Act” means the Industrial Assurance Act 1923.
3. The fees set out in the Schedule hereto shall be payable in respect of the matters set out therein.
4. The Industrial Assurance (Fees) Regulations 1981 (b) are hereby revoked.

These Regulations increase the fees payable in connection with the exercise by the Industrial Assurance Commissioner of his functions under the Industrial Assurance Act 1923. They supersede the Industrial Assurance (Fees) Regulations 1981.
