## COMMON AGRICULTURAL POLICY

**Agricultural Products Processing and Marketing (Improvement Grant) (Amendment) Regulations 1983***Laid before Parliament in draft*

*Made - - - - -* 26th April 1983  
*Coming into Operation* 27th April 1983

The Minister of Agriculture, Fisheries and Food and the Secretary of State, being Ministers designated(a) for the purposes of section 2(2) of the European Communities Act 1972(b) in relation to the common agricultural policy of the European Economic Community, acting jointly, in exercise of the powers conferred upon them by the said section 2(2) and of all other powers enabling them in that behalf, hereby make the following regulations, of which a draft has been approved by resolution of each House of Parliament:—

*Title and commencement*

1. These regulations may be cited as the Agricultural Products Processing and Marketing (Improvement Grant) (Amendment) Regulations 1983, and shall come into operation on the day after the day on which they are made.

*Amendment of the Agricultural Products Processing and Marketing (Improvement Grant) Regulations 1977*

2. The Agricultural Products Processing and Marketing (Improvement Grant) Regulations 1977(c) shall be amended by substituting in regulation 2(1) thereof for the definition of “the Council Regulation”, the following definition:—

“the Council Regulation” means Council Regulation (EEC) No. 355/77 of 15th February 1977(d) on common measures to improve the conditions under which agricultural products are processed and marketed as amended by Council Regulation (EEC) No. 3073/82 of 16th November 1982(e).’

#### EXPLANATORY NOTE

*(This Note is not part of the Regulations.)*

These regulations amend the Agricultural Products Processing and Marketing (Improvement Grant) Regulations 1977 by substituting a new definition of "the Council Regulation" in regulation 2(1) thereof so as to incorporate a reference to the current Community instrument: Council Regulation (EEC) No. 3073/82 of 16th November 1982 amending Council Regulation (EEC) No. 355/77 as regards common measures to improve the conditions under which agricultural products are processed and marketed during the calendar years 1983 and 1984.

The main effect of the amendment is to apply the provisions of the principal regulations to payments made in pursuance of Council Regulation (EEC) No. 355/77 as extended to the calendar years 1983 and 1984 by Council Regulation (EEC) No. 3073/82.
