**1983 No. 650 (C.19) (S.55)**
**ROAD TRAFFIC**
**The Transport Act 1982 (Scotland) (Commencement No. 1)  
Order 1983**

*Made* - - - - - *21st April 1983*

In exercise of the powers conferred on me by section 76(2) of the Transport Act 1982 (a) and of all other powers enabling me in that behalf, I hereby make the following order:—

- 1.—(1) This order may be cited as the Transport Act 1982 (Scotland) (Commencement No. 1) Order 1983.
- (2) In this order “the Act” means the Transport Act 1982.
2. This order shall extend to Scotland only.
3. The provisions of the Act which are referred to in column 1 of the Schedule to this order (which relate to the matters described in column 2 of that Schedule) shall come into force on 30th June 1983.

## EXPLANATORY NOTE

*(This Note is not part of the Order.)*

This Order brings into force on 30th June 1983 the provisions of the Transport Act 1982 which are referred to in column 1 of the Schedule to the order. These provisions relate to the issue of a conditional offer of a fixed penalty by the procurator fiscal and the extension of the jurisdiction of the district court to try any of the offences mentioned in Schedules 1 and 2 to the Act. The order extends to Scotland only.
