Parochial Fees Order 1984

<i>Made (approved by the General Synod)</i>	7th July 1984
<i>Laid before Parliament</i>	23rd July 1984
<i>Coming into Operation</i>	1st January 1985

We, the Church Commissioners for England, in exercise of the powers conferred on us by section 2(1) of the Ecclesiastical Fees Measure 1962(a) and all other powers enabling us in that behalf, do hereby order as follows:—

1. The Parochial Fees Order 1982(b) is hereby altered in the manner indicated in paragraph 2 hereof.
2. The Schedule hereto is substituted for Part I of the Schedule to the Parochial Fees Order 1982.
3. This Order may be cited as the Parochial Fees Order 1984, and shall come into operation on the 1st January 1985.
