# The (A38) Exeter-Leeds Trunk Road (Cappers Lane Link) (Trunking) Order 1984

Coming into Operation

The Secretary of State for Transport makes this Order in exercise of powers conferred by section 10 of the Highways Act 1980 (a) and now vested in him(b) and of all other enabling powers:-

1. The highways along the routes described in the Schedule to this Order and shown by thin black hatching on the deposited plan and which connect the Trunk Road (A38) with another highway at the place stated in that Schedule (the highways along these routes being in this Order referred to as "the slip roads") shall become trunk roads as from the date on which this Order comes into operation.

#### 2. In this Order:

(i) "the deposited plan"

means the plan numbered HA10/2WM 112 marked "The (A38) Exeter-Leeds Trunk Road (Cappers Lane Link) (Trunking) Order 1984" signed by authority of the Secretary of State and deposited at the Department of Transport, Romney House, 43 Marsham Street, London SW1P3PY;

(ii) "the slip roads"

has the meaning given in Article 1 of this

Order:

(iii) "the Trunk Road"

means the Exeter-Leeds Trunk Road

(A38).

3. This Order shall come into operation on 24th August 1984 and may be cited as the (A38) Exeter-Leeds Trunk Road (Cappers Lane Link) (Trunking) Order 1984.

#### **SCHEDULE**

#### ROUTES OF THE SLIP ROADS TO BECOME TRUNK ROAD

The routes of the slip roads are at Lichfield in the County of Staffordshire and are as follows:—

- (1) An exit route from the northbound carriageway of the Exeter-Leeds Trunk Road (A38) to connect with Cappers Lane (C204) numbered 1 on the deposited plan.
- (2) An access route from Cappers Lane (C204) to connect with the southbound carriageway of the Exeter-Leeds Trunk Road (A38) numbered 2 on the deposited plan.

#### EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order gives trunk road status to the slip roads linking the Lichfield Eastern By-pass to Cappers Lane at Lichfield in the County of Staffordshire.

They were provided as part of the Cappers Lane improvement scheme, carried out by Staffordshire County Council, and were transferred to the Department of Transport under the provisions of "The County Council of Staffordshire (Cappers Lane Link Lichfield Phase II Classified Road) (Side Roads) Order 1982".
