- 1. This Order may be cited as the Matrimonial and Family Proceedings Act 1984 (Commencement No. 1) Order.

The provisions of the Matrimonial and Family Proceedings Act 1984 (hereinafter referred to as "the Act") which are listed in column (1) of the Schedule to this Order and which relate to the enactments amended or repealed by those provisions as indicated in column (2) of that Schedule shall come into operation on 12th October 1984.

(This Note is not part of the Order.)

Section 47(1)(a) of the Matrimonial and Family Proceedings Act 1984 brings into force Parts I and II, save section 10, and paragraphs 1 and 2 of Schedule 2 on 12th October 1984. This Order brings into force on that date provisions which amend or repeal the enactments indicated in the Schedule in respect of proceedings in magistrates' courts as well as matrimonial proceedings in the High Court and county court under the Matrimonial Causes Act 1973.
