The National Health Service (Determination of Districts) Amendment Order 1984

The Secretary of State for Social Services, in exercise of powers conferred on him by section 8(2) of the National Health Service Act 1977(a) and of all other powers enabling him in that behalf, and after consultation, in accordance with section 8(5) of that Act, with bodies who he considers are concerned with the Order, hereby makes the following Order:—

Citation and commencement

1. This Order may be cited as the National Health Service (Determination of Districts) Amendment Order 1984 and shall come into operation on 6th April 1984.

Amendment of the National Health Service (Determination of Districts) Order 1981.

2.— (1) The National Health Service (Determination of Districts) Order 1981(b) shall be amended in accordance with the following paragraphs.

(2) In Part 1 of Schedule 1 (Health Authority districts in England)—

- (a) in the entry in column (3) opposite the name “Basildon and Thurrock District” in column (2) after the word “Basildon” there shall be inserted the words “as altered by the Basildon and Castle Point (Areas) Order 1984(c) made under Part IV of the Local Government Act 1972(d)”;
- (b) in the entry in column (3) opposite the name “Southend District” in column (2) after the words “Castle Point” there shall be inserted the words “as altered by the Basildon and Castle Point (Areas) Order 1984 made under Part IV of the Local Government Act 1972”.

EXPLANATORY NOTE
(This Note is not part of the Order.)

This Order amends the National Health Service (Determination of Districts) Order 1981 which determines districts in England and Wales for which District Health Authorities are established under the National Health Service Act 1977. Amendment is made in consequence of a change in the boundaries of the local government districts of Basildon and Castle Point effected by the Basildon and Castle Point (Areas) Order 1984 so that parts of the district of the Basildon and Thurrock Health Authority are transferred to the district of the Southend Health Authority and parts of the district of the Southend Health Authority are transferred to the district of the Basildon and Thurrock Health Authority.
