**BETTING, GAMING AND LOTTERIES**

**The Gaming Act (Variation of Fees) (Scotland) Order 1984**

In exercise of the powers conferred on me by sections 48(5) and 51(4) of the Gaming Act 1968(a), and of all other powers enabling me in that behalf, I hereby make the following order:

1.—(1) This order may be cited as the Gaming Act (Variation of Fees) (Scotland) Order 1984 and shall come into operation on 2nd April 1984.

(2) This order shall extend to Scotland only.

2. The provisions of section 48 of the Gaming Act 1968(b) specified in the first column of the Schedule to this Order (which relate to fees charged in respect of the matters mentioned in the second column of that Schedule) shall have effect as if, for the references to the sums specified in those provisions (for which the sums mentioned in the third column of that Schedule were substituted by the order revoked by this order), there were substituted references to the sums specified in the fourth column thereof, respectively.

3. Article 2 of, and the Schedule to, the Gaming Act (Variation of Fees) Order 1983(c) are hereby revoked.
