The Anglian Water Authority (Alteration of Boundaries of the Southery and District Internal Drainage District) Order 1984

Made - - - -

8th February 1984

Coming into Operation

23rd March 1984

Whereas the Anglian Water Authority prepared and submitted to the Minister of Agriculture, Fisheries and Food (hereinafter called "the Minister") for confirmation a Scheme (hereinafter called "the Scheme") under section 11(1) of the Land Drainage Act 1976(a) in relation to the Southery and District Internal Drainage District;

And whereas the Minister has decided to confirm the Scheme, a copy of which is annexed hereto;

Now, therefore, the Minister, in exercise of the powers conferred upon him by sections 11(4) and 109(6) of the Land Drainage Act 1976, and of all other powers enabling him in that behalf, hereby makes the following Order:—

1. This Order may be cited as the Anglian Water Authority (Alteration of Boundaries of the Southery and District Internal Drainage District) Order 1984 and shall, unless subject to special parliamentary procedure, come into operation on the date of its confirmation by the Minister.

2. The Scheme is hereby confirmed.

3. The expenses of the Minister in connection with the making and confirmation of this Order shall be borne by the Anglian Water Authority and shall be part of the administrative expenses of that Authority.

LAND DRAINAGE ACT 1976
ANGLIAN WATER AUTHORITY
SOUTHERY AND DISTRICT INTERNAL DRAINAGE DISTRICT

The Anglian Water Authority (hereinafter called "the Water Authority") pursuant to section 11(1) of the Land Drainage Act 1976 have prepared the following Scheme providing for the alteration of the boundaries of the Southery and District Internal Drainage District (hereinafter called "the Internal Drainage District") and for matters supplemental thereto or consequential thereon;

And the Water Authority submit the Scheme to the Minister of Agriculture, Fisheries and Food (hereinafter referred to as "the Minister") for confirmation under section 11(4) of the said Act of 1976.

SCHEME

1. This Scheme shall come into operation on a day to be appointed by the Minister and such day is hereinafter called "the appointed day".

2. On the appointed day the boundaries of the Internal Drainage District as constituted by the Scheme confirmed by the Anglian Water Authority (Southery and District Internal Drainage District) Order 1981(a) (hereinafter called "the 1981 Order") shall be altered so as to include within the Internal Drainage District those lands lying in the Parishes of Hilgay and Methwold in the Borough of King's Lynn and West Norfolk in the County of Norfolk which are shown coloured green edged red on the map sealed by the Water Authority in relation to this Scheme to the effect that consequent upon such alterations as aforesaid the Internal Drainage District shall comprise the lands lying in the Parishes of Feltwell, Hilgay, Hockwold cum Wilton, Methwold and Southery all in the said Borough of King's Lynn and West Norfolk in the said County of Norfolk, and lands lying in the Parish of Lakenheath in the District of Forest Heath in the County of Suffolk which are shown in part coloured red edged red and in part coloured green edged red on the said map.

3. The provisions of the Scheme confirmed by the 1981 Order shall, where applicable, apply to the added lands as if such lands had formed part of the Internal Drainage District immediately before the appointed day.
