**1984 No. 713****JUVENILE COURTS AND OFFENDERS****The Juvenile Courts (London) (Amendment) Order 1984**

*Made - - - - -* 21st May 1984  
*Coming into Operation* 1st June 1984

In exercise of the powers conferred upon me by paragraphs 14 and 20 of Schedule 2 to the Children and Young Persons Act 1933(a), as amended by section 17(1) of the Children and Young Persons Act 1963(b) read with section 12(1) of the Administration of Justice Act 1964(c), I hereby make the following Order:—

**1.** This Order may be cited as the Juvenile Courts (London) (Amendment) Order 1984 and shall come into operation on 1st June 1984.

**2.** In this Order, “the 1975 Order” means the Juvenile Courts (London) Order 1975(d).

**3.** For Schedule 1 to the 1975 Order there shall be substituted the Schedule set out in the Schedule to this Order.

**4.** For Article 5 of the 1975 Order there shall be substituted the following Article:—

“**5.** A juvenile court may sit at any time, in case of need, either at 185 Marylebone Road, NW1 5QG or in a magistrates’ room in the magistrates’ court at Bow Street WC2E 4AS for the purpose of hearing cases arising in any part of the metropolitan area.”.

## EXPLANATORY NOTE

*(This Note is not part of the Order.)*

This Order amends the Juvenile Courts (London) Order 1975, which assigns divisions to juvenile courts for the Inner London boroughs and the City of London and specifies the places where such courts may sit. The effect of the amendments is to add 185 Marylebone Road, NW1 as a place of sitting for the juvenile courts for the East Central Division (in addition to 163A Seymour Place, W1 and 1 Digswell Street, N7), the West Central Division, the West London (Hammersmith) Division, the West London (Kensington and Chelsea) Division and the Westminster Division in addition to, in each case, 163A Seymour Place, W1. The Order also provides that, in case of need, a juvenile court may sit at 185 Marylebone Road, NW1 to hear cases arising in any part of the Inner London boroughs or the City of London in addition to a magistrates' room in the magistrates' court at Bow Street, WC2.
