**The Customs Duties (ECSC) (Amendment No. 10)
Order 1985**

Coming into Operation 5th July 1985

The Treasury, by virtue of the powers conferred on them by section 5(1) and (3) of the European Communities Act 1972(a) and of all other powers enabling them in that behalf, on the recommendation of the Secretary of State, hereby make the following Order:—

1. This Order may be cited as the Customs Duties (ECSC) (Amendment No. 10) Order 1985 and shall come into operation on 5th July 1985.

2. From the coming into operation of this Order, Article 6(1) of the Customs Duties (ECSC) Order 1981(b) (which exempts from duty goods to which that Order applies originating in certain countries) shall not apply to goods which fall within headings 73.11A.I, 73.11A.IV.a)1 and 73.11B which originate in Yugoslavia.

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order, which comes into operation on 5th July 1985, amends the Customs Duties (ECSC) Order 1981 ("the main Order") which charges customs duties in accordance with the unified ECSC tariff on ECSC products imported into the United Kingdom except from other Member States of the European Coal and Steel Community (ECSC) and from certain other countries named in Schedule 1 to the main Order.

This Order reimposes duties on goods falling within headings 73.11A.I, 73.11A.IV.a)1 and 73.11B which originate in Yugoslavia.

This Order implements a reintroduction of duty made pursuant to Article 1, paragraph 3 of a decision 84/556/ECSC of the representatives of the governments of the Member States of the European Coal and Steel Community meeting within the Council on 6th November 1984 (OJ No L306, 23.11.1984, p.75). Decision 84/556/ECSC of 6th November 1984 established ceilings for imports of certain ECSC goods originating in Yugoslavia. These ceilings have now been reached on goods falling within the above headings.

The Commissions communication to Member States giving notice of the reintroduction of customs duties is published in OJ No C162, 2.7.1985.
