LAND DRAINAGE

**The Anglian Water Authority (Alteration of Boundaries of the
Felixstowe Internal Drainage District) Order 1984**

Made - - - - 22nd November 1984
Coming into Operation 14th January 1985

Whereas the Anglian Water Authority prepared and submitted to the Minister of Agriculture, Fisheries and Food (hereinafter called "the Minister") for confirmation a Scheme (hereinafter called "the Scheme") under section 11(1) of the Land Drainage Act 1976(a) in relation to the Felixstowe Internal Drainage District;

And whereas the Minister has decided to confirm the Scheme subject to the modifications set out in Article 2 of this Order;

And whereas a copy of the Scheme with the said modifications incorporated therein is annexed hereto;

Now, therefore, the Minister in exercise of the powers conferred upon him by sections 11(4) and 109(6) of the Land Drainage Act 1976, and of all other powers enabling him in that behalf, hereby makes the following Order:—

1. This Order may be cited as the Anglian Water Authority (Alteration of Boundaries of the Felixstowe Internal Drainage District) Order 1984 and shall unless subject to special parliamentary procedure, come into operation on the date of its confirmation by the Minister.

2. The Scheme is hereby confirmed subject to the following modifications (which have been incorporated in the Scheme and shown on the map sealed by the Authority in relation thereto) that is to say:—

(1) In the preamble:—

(i) the words "LAND DRAINAGE ACT 1976" shall be inserted in the heading;

(ii) in lines 9 and 10, from the word "in" to the figures "1983" shall be deleted.

(2) In paragraph 2 for the definition of "the original lands" there shall be substituted the following definition:

"the Internal Drainage District" means the Felixstowe Internal Drainage District as constituted by the 1956 Order(b) and comprising

the lands shown edged red and coloured blue and edged red and coloured green lying in the parishes of Felixstowe, Levington, Nacton, Stratton Hall, Trimley St. Martin, and Trimley St. Mary in the District of Suffolk Coastal in the County of Suffolk;”;

(3) For paragraph 3 there shall be substituted the following paragraph:—

“3. The boundaries of the Internal Drainage District shall be altered so as to exclude therefrom the excluded lands to the effect that consequent upon such alteration the Internal Drainage District shall henceforth comprise the lands shown edged red and coloured green lying in the parishes of Levington, Nacton, Stratton Hall, Trimley St. Martin, and Trimley St. Mary in the District of Suffolk Coastal in the County of Suffolk.”.

3. The expenses of the Minister in connection with the making and confirmation of this Order shall be borne by the Anglian Water Authority and shall be part of the administrative expenses of that Authority.

LAND DRAINAGE ACT 1976

ANGLIAN WATER AUTHORITY

FELIXSTOWE INTERNAL DRAINAGE DISTRICT

The Anglian Water Authority (hereinafter called "the Water Authority") pursuant to section 11(1) of the Land Drainage Act 1976 has prepared the following Scheme providing for the alteration of the boundaries of the Felixstowe Internal Drainage District (hereinafter called "the Internal Drainage District") and for matters supplemental thereto or consequential thereon;

And the Water Authority submits the Scheme to the Minister of Agriculture, Fisheries and Food (hereinafter referred to as "the Minister") for confirmation under section 11(4) of the said Act of 1976.

SCHEME

1. This Scheme shall come into operation on a day to be appointed by the Minister and such day is hereinafter called "the appointed day".

2. In this Scheme:—

"the 1956 Order" means the East Suffolk and Norfolk River Board (Felixstowe Internal Drainage District) Order 1956;

"the sealed map" means the map sealed by the Water Authority in relation to this Scheme;

"the Internal Drainage District" means the Felixstowe Internal Drainage District as constituted by the 1956 Order and comprising the lands shown edged red and coloured blue and edged red and coloured green lying in the parishes of Felixstowe, Levington, Nacton, Stratton Hall, Trimley St. Martin, and Trimley St. Mary in the District of Suffolk Coastal in the County of Suffolk;

"the excluded lands" means the lands lying in the parishes of Felixstowe and Trimley St. Mary in the District of Suffolk Coastal in the County of Suffolk and shown edged red and coloured blue on the sealed map.

3. The boundaries of the Internal Drainage District shall be altered so as to exclude therefrom the excluded lands to the effect that consequent upon such alteration the Internal Drainage District shall henceforth comprise the lands shown edged red and coloured green lying in the parishes of Levington, Nacton, Stratton Hall, Trimley St. Martin, and Trimley St. Mary in the District of Suffolk Coastal in the County of Suffolk.

(This Note is not part of the Order.)
