RATING AND VALUATION

**The Assessor of Public Undertakings Valuations
 (Procedure Dates and Time Limits) (Scotland)
 Order 1985**

Made - - - - - 17th January 1985

Coming into Operation 18th January 1985

In exercise of the powers conferred on me by sections 3 and 5 of the Rating and Valuation (Scotland) Act 1952(a), sections 13(1) and 42(1) of the Valuation and Rating (Scotland) Act 1956(b) and of all other powers enabling me in that behalf, I hereby make the following order:—

1. This order may be cited as the Assessor of Public Undertakings Valuations (Procedure Dates and Time Limits) (Scotland) Order 1985 and shall come into operation on the day after the day on which it is made.

2. In this order—

“the Act” means the Local Government (Scotland) Act 1975(c);

“direction” means a direction given by the Assessor under section 5 of the Act;

“the Assessor” means the Assessor of Public Undertakings (Scotland);

“formula valuation” means a valuation of any lands and heritages which the Assessor is required under any enactment to value determined in accordance with the provisions of section 6 of the Act, of any order made under that section or of any enactment which may be repealed or amended by order made under that section;

“dock or harbour valuation” means a formula valuation of any lands and heritages described in paragraph 8 of Schedule 1 to the Act;

and any other words and expressions used have the same meaning as in the Act.

3. For the year 1986–87 or any subsequent year, other than a year of revaluation, the dates by which certain things require to be done as respects any formula valuation, other than a dock or harbour valuation, shall for each

thing mentioned in column 1 of the Schedule to this order be the date, in the year prior to that to which the valuation relates, set out in column 2 of the Schedule.

4. The Assessor of Public Undertakings Valuations (Procedure Dates and Time Limits) (Scotland) Order 1975(a) and the Assessor of Public Undertakings Valuations (Procedure Dates and Time Limits) (Scotland) Amendment Order 1978(b) are hereby revoked.

Last date for provision of information to the Assessor.	1st September
Last date for transmission to a local authority of a copy of so much of any proposed direction as relates to the valuation of lands and heritages in its area.	15th January
Last date for representations by local authorities.	31st January
Last date for the Assessor to give a direction to a local assessor to enter lands and heritages in the valuation roll, and for the Assessor to transmit to the persons carrying on an undertaking so much of the direction as relates to the lands and heritages of that undertaking.	15th February
Last date for objections by persons carrying on undertakings.	15th March
Last date for alteration of valuations following objections by persons carrying on undertakings.	29th March

EXPLANATORY NOTE

(This Note is not part of the Order.)

This order prescribes for the period between revaluations dates by which certain things require to be done in regard to valuations which the Assessor of Public Undertakings (Scotland) is required to determine, other than valuations of dock or harbour undertakings which follow a separate timetable. It also revokes previous orders.
