The Borough of Tamworth (Electoral Arrangements) Order 1985

Made - - - 23rd April 1985 Coming into operation in accordance with Article 2

Whereas in pursuance of section 51(1) of the Local Government Act 1972 (a), the Local Government Boundary Commission for England on 12th April 1984 submitted to me proposals for the future electoral arrangements for the Borough of Tamworth:

And whereas in giving effect to those proposals I have decided to make certain modifications:

Now, therefore, in exercise of the power conferred upon me by sections 51(2) and 67 of the said Act, I hereby make the following Order:—

1. This Order may be cited as the Borough of Tamworth (Electoral Arrangements) Order 1985.

2. This Order shall come into operation on the ordinary day of election of councillors in 1987 (within the meaning of section 37 of the Representation of the People Act 1983(b)) except that for the purpose of all proceedings preliminary or relating to an election to be held on or after that day it shall come into operation on 10th October 1986.

3. The existing wards of the Borough of Tamworth shall be abolished and that borough shall be divided into ten wards which shall bear the names set out in column 1 of the Schedule to this Order, and each such ward shall comprise the existing areas specified opposite thereto in column 2 of that Schedule.

4. The number of councillors to be elected for each ward constituted by this Order shall be three.

5. Where a boundary is described in the Schedule to this Order as running along a road, railway line, footway, waterway or other similar geographical feature, it shall be treated as running along the centre line thereof.

6. Subject to the provisions of Article 7 below the election of councillors shall be by thirds.

7.—(1) The whole number of councillors for each of the wards constituted by this Order shall be elected at the ordinary elections of councillors in 1987.

(2) Of the councillors elected in 1987 for any ward of the borough-

- (a) one third shall retire in 1988 being, subject to paragraphs (3) and (4) below, the councillor elected by the smallest number of votes;
- (b) one third shall retire in 1990 being, subject as aforesaid, the councillor elected by the next smallest number of votes;
- (c) the remaining councillor shall retire in 1991.

(3) In the case of an equality of votes between any persons elected which makes it uncertain which of them is to retire in any such year, the person to retire in that year shall be determined by lot.

(4) If an election of councillors for any ward is not contested, the person to retire in each such year shall be determined by lot.

(5) Where under this Article any question is to be determined by lot, the lot shall be drawn at the next practicable meeting of the council after the question has arisen, and the drawing shall be conducted under the direction of the person presiding at the meeting.

(6) Except as otherwise provided in the foregoing paragraphs of this Article, the term of office of councillors shall be four years, and all councillors shall retire on the fourth day after the ordinary day of election of councillors for the borough in the year of retirement and the newly elected councillors shall come into office on the day on which their predecessors retire.
