**The High Court of Justiciary Fees Amendment Order 1985**

*Made* - - - 23rd May 1985

*Laid before Parliament* 31st May 1985

*Coming into Operation* 24th June 1985

In exercise of the powers conferred on me by section 2 of the Courts of Law Fees (Scotland) Act 1895(a) and of all other powers enabling me in that behalf, and with the concurrence of the Treasury, I hereby make the following order:—

1. This order may be cited as the High Court of Justiciary Fees Amendment Order 1985 and shall come into operation on 24th June 1985.

2. For the Table of Fees in the Schedule to the High Court of Justiciary Fees Order 1984(b) there shall be substituted the Table of Fees set out in the Schedule to this order.
