EXPLANATORY NOTE

(This Note is not part of the Order.)

This order amends the Court of Session etc. Fees Order 1984 so as to increase a number of the fees of court which may be charged in the offices of the Court of Session in relation to proceedings in the Court of Session and certain related specialised courts.

Apart from the increases which have been applied to some of the fees, there are further changes to three items compared to the Table of Fees under the 1984 Order. In items I5 and K3 of the Table of Fees (dealing respectively with fees for report on a scheme of division and copying by electrical or mechanical means) there is a change as to the manner of calculating the fee. In item I2 one fee is reduced.
