## PUBLIC PASSENGER VEHICLES

**The Public Service Vehicles (Drivers' Licences) (Amendment)  
Regulations 1985**

<i>Coming into Operation</i>	<i>1st July 1985</i>

The Secretary of State for Transport, in exercise of the powers conferred by sections 22(3), 52(1)(b) and 60(1) of the Public Passenger Vehicles Act 1981(a), and of all other enabling powers, and after consultation with representative organisations in accordance with section 61(2) of that Act, hereby makes the following Regulations:—

1. These Regulations may be cited as the Public Service Vehicles (Drivers' Licences) (Amendment) Regulations 1985 and shall come into operation on 1st July 1985.
2. The Public Service Vehicles (Drivers' Licences) Regulations 1985(b) shall be amended in accordance with Regulations 3 and 4 of these Regulations.
3. In Regulation 11 (Fees for licences and duplicates)—
  - (1) in paragraph (1)(a) for “£2” substitute “£3”,
  - (2) in paragraph (1)(b) for “£5” substitute “£10”, and
  - (3) in paragraph (2) for “£2” substitute “£3”.
4. In Schedule 3 (Form of certificate to be issued to an applicant prior to the issue of a licence to him) in the second line of the heading to the certificate for “1984” substitute “1985”.
5. The Public Service Vehicles (Drivers' and Conductors' Licences) (Amendment) Regulations 1984(c) are hereby revoked.

6. Nothing in Regulation 3 of these Regulations shall apply where an application for a licence or a duplicate licence was received before 1st July 1985.

#### EXPLANATORY NOTE

*(This Note is not part of the Regulations.)*

These Regulations amend the Public Service Vehicles (Drivers' Licences) Regulations 1985 by increasing the fees for licences and correcting an error in Schedule 3 (in the title to the form of certificate to be issued to an applicant for a licence who has passed a test). They also revoke the Public Service Vehicles (Drivers' and Conductors' Licences) (Amendment) Regulations 1984 which, on the coming into operation of the Public Service Vehicles (Drivers' Licences) Regulations 1985, ceased to have any effect.

The fee for an exchange licence is increased from £2.00 to £3.00, the fee for an ordinary licence is increased from £5.00 to £10.00 and the fee for a duplicate licence is increased from £2.00 to £3.00. These increases apply where an application is received on or after 1st July 1985.
