## The Police Cadets (Scotland) Amendment Regulations 1986

<i>Made - - - -</i>	<i>22nd January 1986</i>
<i>Laid before Parliament</i>	<i>6th February 1986</i>
<i>Coming into Operation</i>	<i>27th February 1986</i>

In exercise of the powers conferred on me by section 27 of the Police (Scotland) Act 1967<sup>(a)</sup>, and of all other powers enabling me in that behalf, and after taking into consideration the recommendations made by the Police Negotiating Board for the United Kingdom and furnishing the said Board with a draft of the regulations in accordance with section 2(1) of the Police Negotiating Board Act 1980<sup>(b)</sup>, I hereby make the following regulations:—

*Citation*

1. These regulations may be cited as the Police Cadets (Scotland) Amendment Regulations 1986.

*Interpretation*

2. In these regulations any reference to “the principal regulations” is a reference to the Police Cadets (Scotland) Regulations 1968<sup>(c)</sup>.

*Operation and effect*

3. These regulations shall come into operation on 27th February 1986 and shall have effect —

- (a) for the purposes of regulations 4 and 6(a), as from 1st September 1985;
- (b) for the purposes of regulations 5 and 6(b), as from 27th February 1986.

*Amendments*

4. For the Table in Schedule 1 to the principal regulations (which contains scales of pay) there shall be substituted the following table:—

(a) 1967 c.77.  
(b) 1980 c.10.  
(c) S.I. 1968/208; the relevant amending instrument is S.I. 1984/2029.

5. In Schedule 2 to the principal regulations (which relates to charges for board and lodging), for the sum “£369” there shall be substituted the sum “£396”.

*Revocations*

6. The following regulations of the Police Cadets (Scotland) Amendment Regulations 1984(a) are hereby revoked:—

- (a) regulation 6 (which relates to scales of pay) and
- (b) regulation 7 (which relates to charges for board and lodging).

## EXPLANATORY NOTE

*(This Note is not part of the Regulations.)*

These regulations further amend the Police Cadets (Scotland) Regulations 1968.

Regulation 4 increases the pay of police cadets with effect from 1st September 1985. The retrospective effect of these regulations is authorised by section 27(2) of the Police (Scotland) Act 1967.

Regulation 5 increases the charges payable by cadets for board and lodging provided by police authorities from £369 per annum to £396 per annum with effect from 27th February 1986.
