**The Saithe (Channel, Western Waters and Bay of Biscay)
 (Prohibition of Fishing) (Revocation) Order 1986**

The Minister of Agriculture, Fisheries and Food and the Secretaries of State respectively concerned with the sea fishing industry in Scotland, Wales and Northern Ireland, acting jointly, in exercise of the powers conferred on them by sections 5(1) and 15(3) of the Sea Fish (Conservation) Act 1967 (a), and of all other powers enabling them in that behalf, hereby make the following order:—

Title and commencement

1. This order may be cited as the Saithe (Channel, Western Waters and Bay of Biscay) (Prohibition of Fishing) (Revocation) Order 1986 and shall come into operation on 23rd September 1986.

Revocation

2. The Saithe (Channel, Western Waters and Bay of Biscay) (Prohibition of Fishing) Order 1986(b) is hereby revoked.

EXPLANATORY NOTE

(This Note is not part of the Order.)

This order revokes the Saithe (Channel, Western Waters and Bay of Biscay) (Prohibition of Fishing) Order 1986 which prohibited, with an exception, fishing for saithe (*Pollachius virens*) by any British fishing boat registered in the United Kingdom, the Isle of Man or the Channel Islands within ICES statistical sub-areas VII (Channel and Western Waters) and VIII (Bay of Biscay) with effect from 7th July 1986.
