**The Social Security Act 1986 (Commencement No.2)
Order 1986**

The Secretary of State for Social Services, in exercise of the powers conferred on him by section 88(1) of the Social Security Act 1986(a) and of all other powers enabling him in that behalf, hereby makes the following order:—

1. This order may be cited as the Social Security Act 1986 (Commencement No.2) Order 1986.
