The Montgomeryshire (Communities) Order 1986

Made	21st November 1986
Coming into operation—	
For the purposes described in article 2(1)	1st January 1987
For all other purposes	1st April 1987

Whereas the Local Government Boundary Commission for Wales, under paragraph 6 of Schedule 10 to the Local Government Act 1972(a), made proposals to the Secretary of State for Wales in relation to communities in the District of Montgomery:

And whereas the District is now named Montgomeryshire:

Now, therefore, the Secretary of State for Wales, in exercise of his powers under paragraph 7 of the said Schedule and section 67(4) and (5) of the said Act as applied by paragraph 9 of the said Schedule, and of all other powers enabling him in that behalf, hereby makes the following order giving effect to the said proposals with modifications:—

Title and commencement

- 1. This order may be cited as the Montgomeryshire (Communities) Order 1986.
- 2.—(1) 1st January 1987 is hereby specified as the day on which this order shall come into operation for any purposes set out in regulation 4(1) (Coming into operation of order) of the Regulations as modified by paragraph (2).

For all other purposes this order shall come into operation on the appointed day.

(2) In the said regulation 4(1), item (e) shall not apply in relation to the constitution of any new community council.

Interpretation

3. In this order—

"the appointed day" means 1st April 1987;

"new community" means a community constituted by this order;

"new community council" means a community council established by this order;

"new community ward" means a community ward formed by this order;

"the Regulations" means the Local Government Area Changes Regulations 1976(a) as amended by the Local Government Area Changes (Amendment) Regulations 1978(b); and

"Schedule 1" and "Schedule 2" mean Schedule 1 and Schedule 2 to this order.

The boundary map

- 4.—(1) In this order, "the boundary map" means the map issued by the Welsh Office and marked "Boundary map of the Montgomeryshire (Communities) Order 1986". The sheets of the boundary map are respectively marked with the numbers 1 to 111.
- (2) Regulation 5(3)(a)(ii) of the Regulations (which requires the supply of prints of maps referred to in orders to the Secretary of State for Social Services) shall not apply.

Communities

- 5. In the District of Montgomeryshire as altered by the Ceredigion (Communities) Order 1986(c)—
- (1) the twenty-seven communities of Aberhafesp, Berriew, Bettws, Carno, Carreghofa, Churchstoke, Kerry, Llanbrynmair, Llandinam, Llandysilio, Llanerfyl, Llanfair Caereinion, Llanfechain, Llanfihangel, Llanfyllin, Llangurig, Llangyniew, Llangynog, Llanidloes, Llanidloes Without, Llanwddyn, Machynlleth, Manafon, Montgomery, Newtown and Llanllwchaiarn, Trefeglwys and Tregynon shall continue;
- (2) the two communities of Bausley and Llanwnog shall continue but shall be renamed and are hereinafter referred to as Bausley with Criggion and Caersws respectively;
- (3) the twenty-eight existing communities of Caereinion Fechan, Castle Caereinion (Rural), Cemmaes, Darowen, Forden, Garthbeibio, Guilsfield (Without), Hirnant, Isygarreg, Llandrinio, Llandyssil, Llangadfan, Llanllugan, Llanmerewig, Llanrhaeadr-ym-Mochnant, Llansantffraid Deytheur, Llansantffraid Pool, Llanwrin, Llanwyddelan, Meifod, Middletown, Mochdre, Penegoes, Pennant, Penstrowed, Trelystan, Uwchygarreg and Welshpool shall be abolished;
- (4) sixteen new communities to be known as Banwy, Cadfarch, Castle Caereinion, Dwyriw, Forden, Glantwymyn, Guilsfield, Llandrinio, Llandyssil, Llanrhaeadr-ym-Mochnant, Llansantffraid, Meifod, Mochdre, Pen-y-Bont-Fawr, Trewern and Welshpool shall be constituted; and
- (5) the communities named in paragraphs (1), (2) and (4) shall consist of the areas shown by the relevant continuous red lines on the boundary map.

Community councils

- 6.—(1) The community council of any community named in paragraph (3) of article 5 shall be dissolved.
- (2) The community wards of the communities of Bausley, Kerry, Llanbrynmair, Llanwnog, Machynlleth, Newtown and Llanllwchaiarn, Penegoes and Welshpool shall be abolished.
 - (3) There shall be a community council for each new community.
- (4) From the appointed day to 11th May 1987 any person in office immediately before the appointed day as councillor of any community or community ward named or described in column (1) of Schedule 1 shall be a councillor of the community specified in respect of such community or community ward in column (2).
 - (5) As from 11th May 1987-
 - (a) the communities in respect of which new community wards are named in column (2) of Schedule 2 shall be divided into such wards, such wards consisting of the areas shown by the relevant continuous green lines on the boundary map;
 - (b) the number of councillors for each community named in column (1) of Schedule 2 not divided into community wards, and for each new community ward, shall be that shown in respect thereof in column (3).
- (6) Community councillors for the new communities named in column (1) of Schedule 2 not divided into community wards, and for the new community wards, shall be elected on 7th May 1987. The persons elected shall come into office on 11th May 1987 and shall retire on the fourth day after the ordinary day of election of councillors in 1991.
- (7) The annual meetings of the new community councils for 1987 shall be convened by the officer appointed by the District Council of Montgomeryshire for the purpose.
- (8) As from 11th May 1987 the number of councillors for any community named in column (1) of the following table shall be that specified in respect of the community in column (2).

Privileges and rights of former boroughs

8. Any privileges or rights belonging immediately before 1st April 1974 to the burgesses of the former borough of Llanfyllin, Llanidloes, Montgomery or Welshpool shall belong to the inhabitants of the community of Llanfyllin, Llanidloes, Montgomery or Welshpool, as the case may be, as existing on and after the appointed day.

Residuary successors

9. In relation to any authority named in column (1) of the following table, for the purposes of any provision of the Regulations which refers to the residuary successor of a dissolved authority, the new community council specified in respect of the first-mentioned authority in column (2) is hereby specified as the residuary successor of such authority.

Expenses of new community councils

11. In the year beginning on the appointed Ay the District Council of Montgomeryshire may levy rates in each new community and make payments to the new community council as if such council had issued a precept to the district council requiring the payment of a sum not exceeding the product of a rate of 14p in the pound calculated on the total rateable value as set out in the valuation list on the appointed day.

Cemeteries

- 12.—(1) In relation to any relevant cemetery, in the period of 25 years beginning on the appointed day—
 - (a) any inhabitant of a specified area shall be entitled to the same rights of burial as the inhabitants of the relevant area;
 - (b) any provisions in relation to inhabitants in any table of fees in force in respect of the cemetery shall apply to the inhabitants of a specified area as they apply to the inhabitants of the relevant area;
 - (c) no differential charges shall be imposed on the inhabitants of a specified area.
- (2) Subject to paragraph (1), any provisions in relation to inhabitants of any community abolished by article 5(3) in any table of fees in force in respect of any relevant cemetery shall apply to the inhabitants of the relevant area.
 - (3) In this article—

"relevant cemetery" means a cemetery to which the Local Authorities' Cemeteries Order 1977(a) applies maintained immediately before the appointed day by the council of a community abolished by article 5(3) (or by the councils of two or more such communities);

"the relevant area" means the area transferred from such community (or communities) to the community in which the cemetery is situated; and

"specified area" means an area so transferred to any other community.

- (4) Paragraphs (1) to (3) are supplementary to paragraphs (2) and (3) of regulation 35 of the Regulations.
- (5) In the application of paragraph (2) of article 17 of the Glyndŵr (Communities) Order 1984(b) in relation to the Llanrhaeadr ym Mochnant Public Cemetery, the reference in paragraph (3) of such article to the area of the Community of Llanrhaeadr-ym-Mochnant in the District of Montgomery as existing on and after the appointed day shall be construed as a reference to the new community of Llanrhaeadr-ym-Mochnant, and paragraph (2) of regulation 35 of the Regulations shall apply to the areas of the existing community of Llanrhaeadr-ym-Mochnant not included in the said new community.



Communities

- 6. In the District of Carmarthen as altered—
- (1) the thirty-four communities of Abergwili, Abernant, Carmarthen, Cenarth, Cilymaenllwyd, Cynwyl Elfed, Eglwyscummin, Laugharne Township, Llanboidy, Llanddarog, Llanddowror, Llandyfaelog, Llanfihangel-ar-Arth, Llanfihangel Rhos-y-Corn, Llangain, Llangeler, Llangunnor, Llangyndeyrn, Llangynin, Llangyrog, Llanllawddog, Llanllwni, Llanpumsaint, Llansteffan, Llanwinio, Llanybydder, Llanycrwys, Meidrim, Newcastle Esnlyn, Pencarreg, Pendine, St. Clears, St. Ishmael and Whitland shall continue;
- (2) the two communities of Newchurch and Trelech a'r Betws shall continue but shall be renamed and are hereinafter referred to as Newchurch and Merthyr, and Trelech respectively;
- (3) the six existing communities of Grondre, Henllanfallteg, Llanarthney, Llandissilio East, Llanfàllteg West and Llangan West shall be abolished;
- (4) five new communities to be known as Bronwydd, Clynderwen, Gorslas, Henllanfallteg and Llanar new shall be constituted;
- (5) the communities named in paragraphs (1), (2) and (4) shall, subject to the provision of paragraph (6), consist of the areas shown by the relevant continuous red lines on the boundary map; and
- (6) any island, rock or sandbank forming part of an existing community in the District which is not expressly shown on the boundary map as part of a community named in paragraph (1) or (4) shall form, or continue to form, part of such a community (and if that community is divided into wards of the ward) nearest to which any part of such island, rock or sandbank lies.

Electoral divisions and district wards

7. Where any boundary of the District of Carmarthen altered by article 5 is also the boundary of an electoral division of the County of Dyfed or of a ward of the said district, the alteration shall extend to such electoral division or ward.

Community councils

- **8.**—(1) The community council of any community named in paragraph (3) of article 6 shall be dissolved.
- (2) The community wards of the communities of Carmarthen, Cenarth, Cilymaenllwyd, Eglwyscummin, Henllanfallteg, Llanarthney, Llanboidy, Llanddowror, Llandissilio East, Llangeler, Llangyndeyrn, Llansteffan, Llanybydder, Newchurch, Pencarreg, St. Clears and St. Ishmael shall be abolished.
 - (3) There shall be a community council for each new community.
 - (4) From the appointed day to 11th May 1987—
 - (a) any person in office immediately before the appointed day in any office described in column (1) of the following table shall be a councillor of the community specified in respect thereof in column (2).

(b) The Community Council of Bronwydd l consist of the district councillors for the wards wholly or partly containing the area of the community.

(5) As from 11th May 1987—

- (a) the communities in respect of which we community wards are named in column (2) of Schedule 2 shall be divided into such wards, such wards consisting, subject to the provision of paragraph (6) of article 6, of the areas shown by the relevant continuous green lines on the boundary map;
- (b) the number of councillors for each new community named in column (1) of Schedule 2 not divided into community wards, and for each new community ward, shall be that shown in respect thereof in column (3).
- (6) Community councillors for the new communities named in column (1) of Schedule 2 not divided into community wards, and for the new community wards, shall be elected on 7th May 1987. The persons elected shall come into office on 11th May 1987 and shall retire on the fourth day after the ordinary day of election of councillors in 1991.
- (7) The annual meetings of the new community councils for 1987 shall be convened by the officer appointed by the District Council of Carmarthen for the purpose.
- (8) As from 11th May 1987 the number of councillors for any community named in column (1) of the following table shall be that specified in respect of the community in column (2).
