# The Rules of the Air and Air Traffic Control (Second Amendment) Regulations 1986

Made - - - - - - 4th December 1986

Coming into operation for the purposes of regulation 2(3)

For all other purposes 27th January 1987

The Secretary of State for Transport, in exercise of his powers under article 64(1) of the Air Navigation Order 1985(a), and of all other powers enabling him in that behalf, hereby makes the following Regulations—

- 1. These Regulations may be cited as the Rules of the Air and Air Traffic Control (Second Amendment) Regulations 1986 and shall come into operation for the purposes of regulation 2(3) on 9th April 1987 and for all other purposes on 27th January 1987.
- 2. The Schedule to the Rules of the Air and Air Traffic Control Regulations 1985(b) shall be amended as follows—
  - (1) For the heading and paragraph (1) of rule 32 there shall be substituted—
    "Access to and movement of persons and vehicles on the aerodrome
    - **32**—(1) A person or vehicle shall not go onto any part of an aerodrome (not being a part of the aerodrome which is a public right of way) without the permission of the person in charge of that part of the aerodrome, and except in accordance with any conditions subject to which that permission may have been granted.".
- (2) In rule 33(4) for the words "rule 35(3)(b)" there shall be substituted "rule 17(7)(c)".
- (3) In the Table to rule 35(1) for the words "at all times" in Column 2 of entry (a) there shall be substituted the words "at such times as are notified".
  - (4) For rule 37 there shall be substituted the following rule:
    - "37. The commander of an aircraft shall not make use of any radio navigation aid without complying with such restrictions and appropriate procedures as may be notified in relation to that aid unless authorised by an air traffic control unit:

Provided that he shall not be required to comply with this rule if he is required to comply with rule 27 of these Rules.".

## **EXPLANATORY NOTE**

(This Note is not part of the Regulations.)

These Regulations amend the Rules of the Air and Air Traffic Control Regulations 1985. In addition to one minor amendment the following changes are made:

- (1) The requirement in rule 32(1) that a person shall not without permission go on to a part of an aerodrome provided for the use of aircraft has now been extended to any part of an aerodrome which is not a public right of way (regulation 2(1)).
- (2) The rules relating to flight within the aerodrome traffic zone of a Government aerodrome now apply only during such times as are notified (regulation 2(3)).
- (3) The requirement that the commander of an aircraft making use of a radio navigation aid must comply with notified restrictions and procedures has now been extended to cover aids provided by satellite as well as those in the United Kingdom, but the rule no longer applies where the commander is otherwise authorised by an air traffic control unit or where he is required to comply with rule 27 (regulation 2(4)).
