The Air Navigation (Dangerous Goods) (Amendment) Regulations 1986

5th December 1986 Made -Coming into Operation 1st January 1987

The Secretary of State for Transport, in exercise of his powers under article 44(1) of the Air Navigation Order 1985 (a) and of all other powers enabling him in that behalf, hereby makes the following Regulations—

Citation and commencement

These Regulations may be cited as the Air Navigation (Dangerous Goods) (Amendment) Regulations 1986 and shall come into operation on 1st January 1987.

Amendment of the Air Navigation (Dangerous Goods) Regulations 1985

- 2. The Air Navigation (Dangerous Goods) Regulations 1985 (b) shall be amended as follows:
- (1) In regulation 3(1) there shall be substituted for the sub-paragraph commencing with the words "Technical Instructions" the following-
 - " "Technical Instructions" means the 1987-1988 English language edition of the Technical Instructions for the Safe Transport of Dangerous Goods by Air approved and published by decision of the Council of the International Civil Aviation Organization;";
- (2) In regulation 4 after paragraph (3) there shall be added the following paragraph-
 - "(4) Save for regulations 4(1)(a), 8(1) (but only to the extent that it refers to the provisions in Chapter 2.1 of Part 5 of the Technical Instructions) and 8(2) of these Regulations, these Regulations shall not apply to dangerous goods of the classifications specified in Chapter 2.5 of Part 1 of the Technical Instructions provided that:
 - (a) the dangerous goods do not exceed the appropriate quantity limitations specified therein; and
 - (b) such other conditions as are specified therein are complied with.";
- (3) In regulation 7(6) after the words "unless the radiation level" there shall be inserted the words "resulting from the fixed contamination".

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations amend the Air Navigation (Dangerous Goods) Regulations 1985 by making the following changes:

- (1) The definition of "Technical Instructions" now refers to the 1987–1988 English language edition, approved and published by decision of the Council of the International Civil Aviation Organization (regulation 2(1)).
- (2) With certain exceptions, the Regulations no longer apply to dangerous goods in small quantities of the classifications, and subject to conditions, specified in the Technical Instructions (regulation 2(2)).
- (3) The reference to radiation levels at accessible surfaces in regulation 7(6) of the Regulations is clarified (regulation 2(3)).
