# **CONSUMER CREDIT**

# The Consumer Credit (Exempt Agreements) (No. 2) (Amendment No. 2) Order 1986

*Made - - - 11th December* 1986

Laid before Parliament 12th December 1986

Coming into Operation:

for the purposes of

Article 2(c), (d) and (e) 7th January 1987

Otherwise - - - 2nd January 1987

The Secretary of State, after consulting in accordance with section 16(3) and (9) of the Consumer Credit Act 1974(a) the persons therein referred to, in exercise of the powers conferred on him by sections 16(1) and (4) and 182(2) and (4) of that Act and of all other powers enabling him in that behalf, hereby makes the following Order:—

- 1. This Order may be cited as the Consumer Credit (Exempt Agreements) (No. 2) (Amendment No. 2) Order 1986 and shall come into operation otherwise than for the purposes of Article 2(c), (d) and (e) on 2nd January 1987 and for the purposes of Article 2(c), (d) and (e) on 7th January 1987.
- 2. The Consumer Credit (Exempt Agreements) (No. 2) Order 1985(b) is hereby amended as follows:—
  - (a) in Article 2(2)—
    - (i) by inserting, after the words "a body specified in Part I of the Schedule to this Order", the words "or a building society authorised under the Building Societies Act 1986"; and
    - (ii) in paragraph (a), by inserting, after the words "section 16(2)(a)", the words "or (c)";
    - (iii) in paragraph (b), by omitting the word "financing" and substituting therefor the words "to finance"; and
    - (iv) by inserting, after paragraph (c), the following:
      - "(d) a debtor-creditor agreement secured by any land mortgage where the creditor is a building society authorised under the

Building Societies Act 1986 and its offer to enter into such agreement was made in writing before 1st January 1987 and the agreement was executed before 1st February 1987.".

- (b) in Part I of the Schedule, in the list of Insurance Companies
  - (i) by inserting, at the appropriate place in alphabetical order, the name "General Portfolio Life Insurance Public Limited Company";
  - (ii) by omitting the names
    - "American International Life Assurance Company of New York"
    - "The Parcels & General Assurance Association Limited"
    - "U.K. Life Assurance Company Limited"; and
  - (iii) by omitting the names
    - "Avon Assurance PLC"
    - "Norwich Union Insurance Group (Managed Funds) Limited"
    - "The Sentinel Insurance Group plc"
    - "Transinternational Life Insurance Company Limited"
    - "Trident General Insurance Company Limited"

and substituting therefor respectively, at the appropriate places in alphabetical order, the names

  - (i) by inserting, at the appropriate place in alphabetical order, the following entry:

"TSB Scotland public limited company Agreements of a description falling within section 16(2) of the Act, being agreements made pursuant to section 145 of the Housing (Scotland) Act 1966(a), section 6(5) or 31 of the Tenants' Rights Etc. #### **EXPLANATORY NOTE**

(This Note is not part of the Order.)

This Order further amends the Consumer Credit (Exempt Agreements) (No. 2) Order 1985 ("the principal Order") insofar as it provides for the exemption of certain consumer credit agreements secured on land where the creditor is a body specified in the Schedule to the principal Order, consequent upon the coming into force of relevant provisions of the Building Societies Act 1986 and the Housing and Planning Act 1986. The Order:

- (a) provides for the exemption of certain agreements made by a building society which is an authorised building society within the meaning of the Building Societies Act 1986, and also adjusts the wording of Article 2(2) of the principal Order (Article 2(a));
- (b) amends the list of insurance companies in Part I of the Schedule to the principal Order by adding one name, omitting three names and amending five names (Article 2(b));
- (c) amends the entries in Part II of the Schedule to the principal Order relating to certain companies in the TSB group, and omitting certain entries relating to bodies which are housing authorities within the meaning of section 16(6A) of the Consumer Credit Act 1974 ("the 1974 Act"), as inserted by the Housing and Planning Act 1986 ("the 1986 Act") (Article 2(c) and (d)); and
- (d) adds a new list of bodies corporate named or specifically referred to in an order under the Housing Act 1985 (c.68), pursuant to the power in section 16(1)(ff) of the 1974 Act as inserted by the 1986 Act (Article 2(e)).
