### CONTAMINATION OF FOOD

# The Food Protection (Emergency Prohibitions) (Wales) (No. 2) Amendment No. 5 Order 1986

Made - - 17th December 1986

Laid before Parliament 17th December 1986

Coming into Operation 18th December 1986

Whereas the Secretary of State is of the opinion, in accordance with section 1(1)(a) of the Food and Environment Protection Act 1985(a), that there has been or may have been an escape of substances of such descriptions and in such quantities and such circumstances as are likely to create a hazard to human health through human consumption of food:

And whereas the Secretary of State is of the opinion, in accordance with section 1(1)(b) of the said Act, that in consequence of the said escape of substances food which is or may be in the future in the area described in Schedule 1 to the Food Protection (Emergency Prohibitions) (Wales) (No. 2) Order 1986(b), or which is derived or may be in the future derived from anything in that area, is, or may be, or may become, unsuitable for human consumption;

Now, therefore, the Secretary of State, in exercise of the powers conferred on him by the said section 1(1) and 24(3) of the said Act, and of all other powers enabling him in that behalf, hereby makes the following order:—

#### Title and commencement

1. This order may be cited as the Food Protection (Emergency Prohibitions) (Wales) (No. 2) Amendment No. 5 Order 1986 and shall come into operation on 18th December 1986.

Partial revocation and amendment

- 2. The Food Protection (Emergency Prohibitions) (Wales) (No. 2) Order 1986 is revoked to the extent that it imposes prohibitions on
  - (a) the slaughter of a sheep which
    - (i) was moved from a place in accordance with a consent given under section 2(1) of the Food and Environment Protection Act 1985 which consent was subject to the condition that the sheep to which it applies should be marked with a blue mark; and
    - (ii) has been examined and marked by an ear-tag by a person authorised in that behalf by one of the Ministers; and
  - (b) the supply or having in possession for supply of meat, or food containing meat, derived from such a sheep,

and accordingly that order is further amended in accordance with the following provisions of this order.

- 3. In article 6, for paragraph (2) there shall be substituted the following paragraph
  - "(2) Paragraph (1) above shall not apply in the case of—
    - (a) any sheep which was moved to a market in accordance with a consent given under section 2(1) of the Act which did not require that the sheep to which it applies should be marked in a manner specified therein; or
    - (b) any sheep which
      - (i) was moved from any place in accordance with a consent given under the said section 2(1) which consent was subject to the condition that the sheep to which it applies should be marked with a blue mark; and
      - (ii) has been examined and marked by an ear-tag by a person authorised in that behalf by one of the Ministers.".

### **EXPLANATORY NOTE**

(This Note is not part of the Order.)

The Food Protection (Emergency Prohibitions) (Wales) (No. 2) Order 1986 ("the principal order"), as amended by S.I. 1986/1707, 1756, 1775 and 1849, contains emergency prohibitions restricting various activities in order to prevent human consumption of food which has been or which may have been rendered unsuitable for that purpose in consequence of the escape of radioactive substances from a nuclear reactor situated at Chernobyl in the USSR. That order designates an area of land in Wales ("the designated area") affected by the escape from which the movement of sheep, and in which the slaughter of sheep, are prohibited.

This order excepts from the prohibition on slaughter and supply throughout the United Kingdom any sheep (and any meat derived from such sheep) identified by a blue paint mark which have been examined and subsequently marked by an ear-tag by an official of the Ministry of Agriculture, Fisheries and Food, Scottish Office or Welsh Office (article 3).
