# The National Health Service (General Medical and Pharmaceutical Services) (Scotland) Amendment (No. 4) Regulations 1986

The Secretary of State, in exercise of powers conferred on him by sections 19, 27 and 108(1) of the National Health Service (Scotland) Act 1978(a), and of all other powers enabling him in that behalf, hereby makes the following regulations:-

### Citation, commencement and interpretation

- 1.—(1) These regulations may be cited as the National Health Service (General Medical and Pharmaceutical Services) (Scotland) Amendment (No. 4) Regulations 1986 and shall come into force for the purposes of regulations 2 and 3 on 1st February 1987 and for all other purposes on 1st August 1987.
- (2) In these regulations "Schedule 2A" means Schedule 2A to the National Health Service (General Medical and Pharmaceutical Services) (Scotland) Regulations 1974(b).

# Amendment of Schedule 2A

2. In Schedule 2A (drugs and other substances not to be supplied by general medical practitioners or prescribed for supply under pharmaceutical services)(c) the following entries shall be deleted:-

### **EXPLANATORY NOTE**

(This Note is not part of the Regulations.)

These regulations amend the National Health Service (General Medical and Pharmaceutical Services) (Scotland) Regulations 1974 ("the 1974 Regulations") which regulate the terms on which doctors and chemists provide general medical services and pharmaceutical services under the National Health Service (Scotland) Act 1978.

Schedule 2A to the 1974 Regulations lists drugs and other substances which cannot be supplied by doctors or prescribed for supply under pharmaceutical services. These regulations add some drugs to, and delete others from, that list. The additions are to be made on two different dates.
