The Factories Act (Hours of Employment Orders and Regulations) Revocation and Amendment Order 1986

Made	18th December 1986

Whereas Part VI of the Factories Act 1961(a) ("the 1961 Act") was amended by section 7 of, and Part III of the Schedule to, the Sex Discrimination Act 1986(b) ("the 1986 Act"), the Secretary of State, in exercise of the powers conferred on him by section 7(4) of the 1986 Act and of all other powers enabling him in that behalf, hereby makes the following Order—

Citation and commencement

1. This Order may be cited as the Factories Act (Hours of Employment Orders and Regulations) Revocation and Amendment Order 1986, and shall come into operation on 27th February 1987.

Preamble and words of enactment: delete the words "women and". Regulation 1: omit the words "woman or"; in paragraph (a) omit the words following the word "fifty-four" to the end of the paragraph; in paragraphs (b), (c), (d) and (e) omit the words "woman or", wherever they occur. Regulation 2: omit the words "women

and", "woman or" and the words following "morning" in the second place where it occurs to the semi-colon, and the words "women or".

Omit the whole of Regulations 3, 4 and 6. Regulation 7: omit the words "woman and" and the words "women and".

Regulation 3: omit the words "women and".

Regulation 4: omit the words "women and", wherever they occur. Regulation 5: omit the words "women

and".

Regulation 6: omit the words "woman or", wherever they occur.

Regulation 7: omit the words "woman or" wherever they occur; in sub-paragraph (b) of paragraph (1) omit the words following the word "year"; in sub-paragraph (f) of paragraph (1) omit the words "woman and" and "women and", wherever they occur; in paragraph (2) omit the words "women and".

Regulation 8: omit the words "women and", wherever they occur.

Regulation 1: omit the words "women and" and the words "women or for all young persons or for all women or."

Regulation 4: omit the words "women and" and the words from "woman" to "or".

Regulation 6: omit the words "women and".

EXPLANATORY NOTE (This Note is not part of the Order.)

This Order revokes various instruments and amends others, which were made under the Factories Act 1937 and other legislation but have effect as if made under the Factories Act 1961. The revocations and amendments are made in consequence of amendments by the Sex Discrimination Act 1986 to the provisions in the Factories Act which relate to the hours and holidays of women and young persons. The amendments made by the 1986 Act, which remove all references to women from those provisions, are brought into force by Commencement Order on the same day as this Order comes into operation. The Regulations revoked by this Order extended the hours that could normally be worked by women in factories.
