**The Restriction on Movement of Spruce Wood
(Amendment) Order 1986**

Made - - - 11th March 1986

Laid before Parliament 18th March 1986

Coming into Operation 8th April 1986

The Forestry Commissioners, in exercise of the powers conferred on them by section 3(1), (2) and (4) of the Plant Health Act 1967(a), and of all other powers enabling them in that behalf, hereby make the following Order :—

Citation and commencement

1. This Order may be cited as the Restriction on Movement of Spruce Wood (Amendment) Order 1986 and shall come into operation on 8th April 1986.

Amendment of the Restriction on Movement of Spruce Wood Order 1982

2. The Restriction on Movement of Spruce Wood Order 1982(b) shall be further amended by substituting for the Schedule thereto (areas in respect of which the movement of spruce wood is restricted) the following Schedule —

(a) 1967 c.8; section 3(1) and (2) was amended by the European Communities Act 1972 (c.68), Schedule 4, paragraph 8; section 3(4) was last amended by the Criminal Justice Act 1982 (c.48), section 42.

"SCHEDULE

Article 3

AREAS IN RESPECT OF WHICH THE MOVEMENT OF SPRUCE WOOD IS RESTRICTED

Counties	Those parts of the counties within which restrictions apply
Avon	That part of the county which lies to the north of the southern boundary of the M4.
Cheshire	That part of the county which lies to the west of the eastern boundary of the M6.
Clwyd	The whole county.
Dyfed	That part of the county which lies to the north of the southern boundary of the A44 and that part which lies to the east of the western boundary of the A487 between Aberystwyth and Llanfarian and of the A485 between Llanfarian and Tregaron and north of the southern boundary of the unclassified road between Tregaron and Abergwesyn.
Gloucestershire	The whole county.
Greater Manchester	That part of the county which comprises the district of Wigan.
Gwent	The whole county.
Gwynedd	That part of the county which comprises the district of Meirionnydd and that part which lies to the east of the western boundary of the A4085 between Caernarfon and Beddgelert, of the A498 between Beddgelert and Tremadog and of the A487 between Tremadog and Porthmadog.
Hereford and Worcester	} The whole county.

Mid Glamorgan	
North Yorkshire	That part of the county which comprises the district of Craven.
Powys	} The whole county.
Shropshire	
South Glamorgan	
Staffordshire	That part of the county which comprises the districts of Cannock Chase, Newcastle-under-Lyme, Stafford, Stoke-on-Trent and South Staffordshire.
West Midlands	That part of the county which comprises the districts of Birmingham, Dudley, Sandwell, Walsall and Wolverhampton."
