The Borough of Blaenau Gwent (Electoral Arrangements) Order 1986

Made - - - 10th March 1986 Coming into operation in accordance with Article 2

Whereas in pursuance of section 58(1) of the Local Government Act 1972 (a), the Local Government Boundary Commission for Wales on 26th September 1985 submitted to me proposals for the future electoral arrangements for the Borough of Blaenau Gwent:

Now, therefore, in exercise of the power conferred upon me by sections 58(2) and 67 of that Act, I hereby make the following Order:—

- 1. This Order may be cited as the Borough of Blaenau Gwent (Electoral Arrangements) Order 1986.
- 2. This Order shall come into operation on the ordinary day of election of councillors in 1987 (within the meaning of section 37 of the Representation of the People Act 1983 (b)) except that for the purpose of all proceedings preliminary or relating to an election to be held on or after that day it shall come into operation on 10th October 1986.
- 3.—(1) The existing wards of the Borough of Blaenau Gwent shall be abolished and that borough shall be divided into seventeen wards which shall bear the names set out in column 1 of the Schedule to this Order, and each such ward shall comprise the existing areas specified in column 2 of that Schedule opposite to the name of the ward as given in column 1, except that the areas of the Abertillery, Blaina, Cwmtillery, Nantyglo and Six Bells wards are the areas demarcated by green lines on the boundary map referred to in the Blaenau Gwent (Communities) Order 1984 (c) and designated on that map by reference to the names of the wards of the Communities of Abertillery and Nantyglo and Blaina as set out in column 2 of Schedule 1 to that Order.
- (2) The number of councillors to be elected for each such ward shall be the number specified in column 3 of the Schedule to this Order opposite to the name of the ward as given in column 1 of that Schedule.
- **4.** Where a boundary is described in the Schedule to this Order as running along a road, railway line, footway, waterway or other similar geographical feature, it shall be treated as running along the centre line thereof.
- 5. The ordinary elections of all councillors for the Borough of Blaenau Gwent shall be held simultaneously on the ordinary day of election of non-metropolitan district councillors in 1987 and every fourth year thereafter.
