**The Local Government Reorganisation (Designation of Staff)
(No. 2) Order 1986**

<i>Made - - - -</i>	<i>25th March 1986</i>

<i>Coming into Operation</i>	<i>1st April 1986</i>

The Secretary of State for the Environment, in exercise of the powers conferred on him by section 52 of the Local Government Act 1985(a), and of all other powers enabling him in that behalf, hereby makes the following order:—

Citation, commencement and interpretation

1.—(1) This order may be cited as the Local Government Reorganisation (Designation of Staff) (No. 2) Order 1986, and shall come into operation on 1st April 1986.

(2) In this order —

“designated” means designated for the purposes of section 52 of the Local Government Act 1985;

“the London order” means the London Government Reorganisation (Designation of Staff) Order 1986(b); and

“the principal order” means the Local Government Reorganisation (Designation of Staff) Order 1986(c).

(3) In determining whether a person is within a description set out in a schedule hereto, no account shall be taken of his temporary secondment or temporary absence from his post —

(i) for training or any other purpose connected with his usual duties; or

(ii) pursuant to any statutory or contractual provision applicable to his employment.

Designation of staff to be transferred from the Greater London Council to successor authorities

2. Any employee of the Greater London Council who is either named or within a description set out in column 1 of Schedule 1 to this order is designated as a person to be transferred to the successor authority specified in column 2 of that Schedule.

Amendment of the London order

3. Article 7(3) of the London order shall not apply to Mr. G. Day, named in section 3 of Part V of the deposited Schedule to that order.

Designation of staff to be transferred from metropolitan county councils to new police authorities

4. Any employee of a metropolitan county council who —

(i) after 30th November 1985, but before 8th February 1986, assumed duties which would (but for their commencement after 30th November) have brought him within a description set out in Schedule 6 to the principal order; and

(ii) continues to carry out those duties until immediately before 1st April 1986 —

is designated as a person to be transferred to the Police Authority for that county.

Designation of staff to be transferred from metropolitan county councils to residuary bodies

5. Any employee of a metropolitan county council mentioned below who is either named or within a description set out in the Schedule so mentioned in relation to that council is designated as a person to be transferred to the residuary body for that metropolitan county —

EXPLANATORY NOTE

(This note is not part of the order.)

This order concerns certain staff of the Greater London Council and the metropolitan county councils. Those councils are abolished on 1st April 1986 by section 1 of the Local Government Act 1985. Under section 52 of that Act, the Secretary of State may designate (either individually or by class or description) employees of such a council for automatic transfer on abolition to any authority inheriting functions or property. Where an individual is so designated there is no termination of, or change in the terms of, his contract of employment.

Certain designations were made in the Local Government Reorganisation (Designation of Staff) Order 1986 (S. I. 1986/192), the London Government Reorganisation (Designation of Staff) Order 1986 (S. I. 1986/426), and the Local Government Reorganisation (Designation of Metropolitan County Council Staff) Order 1986 (S. I. 1986/523). This order makes further designations.

Article 2 and Schedule 1 concern Greater London Council staff. Article 3 revokes a designation in the London Government Reorganisation (Designation of Staff) Order 1986 mentioned above. Article 4 deals with certain metropolitan county council staff to be transferred to new police authorities. The arrangement of Schedules concerning other metropolitan council staff who are to be transferred to residuary bodies is as follows —
