**1986 No. 588 (S. 58)**

**LOCAL GOVERNMENT, SCOTLAND**

**The Local Authorities (Allowances) (Scotland) Amendment Regulations 1986**

*Made* - - - - - 25th March 1986  
*Laid before Parliament* 3rd April 1986  
*Coming into Operation* 24th April 1986

The Secretary of State, in exercise of the powers conferred on him by sections 45, 49A and 50 of the Local Government (Scotland) Act 1973(a), and of all other powers enabling him in that behalf, hereby makes the following regulations:-

*Citation and commencement*

1.—(1) These regulations may be cited as the Local Authorities (Allowances) (Scotland) Amendment Regulations 1986.

(2) These regulations shall come into operation on 24th April 1986.

*Increase in rates of attendance allowance and financial loss allowance*

2. In regulation 3 of the Local Authorities (Allowances) (Scotland) Regulations 1975(b) -

- (a) in paragraph (1) (which prescribes the rate of attendance allowance) for “£16.00” there shall be substituted “£16.70”, and
- (b) in paragraph (2) (which prescribes the rate of financial loss allowance) at sub-paragraph (a) for “£12.00” there shall be substituted “£12.70” and at sub-paragraphs (b) and (c) for “£24.00” where it occurs, there shall be substituted “£25.40”.

*Increase in rates of special responsibility allowance*

3. The Local Authorities (Allowances) (Scotland) Regulations 1975 shall be amended as follows:-

- (a) in paragraph (1) of regulation 3A (which prescribes the maximum rate of special responsibility allowance) at sub-paragraph (a) for “£4,570” there shall be substituted “£4,775” and at sub-paragraph (b) for “£460” in both cases where it occurs there shall be substituted “£480”, and
- (b) for any amount specified in Schedule 2 which is mentioned in column 2 of the Schedule to these regulations there shall be substituted the amount set opposite thereto in column 3 of the Schedule to these regulations.

#### EXPLANATORY NOTE

*(This Note is not part of the Regulations.)*

These regulations increase the maximum rate of attendance allowance payable to members of a local authority and also the maximum rate of financial loss allowance payable to members of a local authority and of other bodies for the performance of an approved duty and who are not entitled to attendance allowance (regulation 2). The regulations also increase the maximum rates of special responsibility allowance which may be paid by a local authority under section 49A of the Local Government (Scotland) Act 1973 and also the total amounts which a local authority may pay thereunder by way of such an allowance in any financial year (regulation 3).
