Present,

The Queen's Most Excellent Majesty in Council

Whereas in pursuance of section 2(3) of the House of Commons (Redistribution of Seats) Act 1949^(a) the Boundary Commission for England have submitted to the Secretary of State a report dated 23rd January 1986 with respect to the areas comprised in certain constituencies in England and showing the constituencies into which they recommend, in accordance with the House of Commons (Redistribution of Seats) Acts 1949 and 1958^(b), that the areas should be divided:

And whereas the Secretary of State has laid that report before Parliament together with the draft of this Order in Council to give effect to the recommendations contained in the report and each House of Parliament has by resolution approved the said draft:

Now, therefore, Her Majesty, in pursuance of section 3 of the House of Commons (Redistribution of Seats) Act 1949, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:—

1.— (1) This Order may be cited as the Parliamentary Constituencies (England) (Miscellaneous Changes) Order 1986.

(2) In this Order “the 1983 Order” means the Parliamentary Constituencies (England) Order 1983(a).

(3) Subject to the proviso to section 3(6) of the House of Commons (Redistribution of Seats) Act 1949, this Order shall come into operation on the fourteenth day after the day on which it is made.

Basingstoke, East Hampshire, Eastleigh, Fareham, Havant, North West Hampshire, Romsey and Waterside and Winchester

2. For the county constituencies of Basingstoke, East Hampshire, Fareham, North West Hampshire, Romsey and Waterside and Winchester and the borough constituencies of Eastleigh and Havant as constituted by the Schedule to the 1983 Order (and described by reference to local government areas as they existed on 1st February 1983), there shall be substituted the constituencies which are named on the left-hand side of Part I of the Schedule to this Order and comprise the areas set out on the right-hand side, which areas are local government areas as they existed on 23rd January 1986 (and accordingly as altered by the East Hampshire and Havant (Areas) Order 1983(b), the Test Valley (Parishes) Order 1984(c), the Hampshire (Areas) Order 1985(d), the Basingstoke and Deane (Parishes) Order 1985(e) and the Winchester (Parishes) Order 1985(f)).

Bridgwater and Taunton

3. For the county constituencies of Bridgwater and Taunton as constituted by the Schedule to the 1983 Order (and described by reference to local government areas as they existed on 1st February 1983) there shall be substituted the constituencies which are named on the left-hand side of Part II of the Schedule to this Order and comprise the areas set out on the right-hand side, which areas are local government areas as they existed on 23rd January 1986 (and accordingly as altered by the West Somerset (Parishes) Order 1983(g) and the Sedgemoor and Taunton Deane (Areas) Order 1984(h)).

Falmouth and Camborne, St. Ives, South East Cornwall and Truro

4. For the county constituencies of Falmouth and Camborne, St. Ives, South East Cornwall and Truro as constituted by the Schedule to the 1983 Order (and described by reference to local government areas as they existed on 5th May 1983 in respect of those parts of the constituencies of South East Cornwall and Truro which consist of wards of the Borough of Restormel and 1st February 1983 in respect of the remainder of those constituencies and the constituencies of Falmouth and Camborne and St. Ives), there shall be substituted the constituencies which are named on the left-hand side of Part III of the Schedule to this Order and comprise the areas set out on the right-hand side, which areas are local government areas as they existed on 23rd January 1986

(and accordingly as altered by the Restormel (Parishes) Order 1983(a), the Carrick (Parishes) Order 1985(b) and the Kerrier (Parishes) Order 1985(c)).

Keighley and Skipton and Ripon

5. For the county constituencies of Keighley and Skipton and Ripon as constituted by the Schedule to the 1983 Order (and described by reference to local government areas as they existed on 5th May 1983 in respect of that part of the constituency of Skipton and Ripon which consists of wards of the Borough of Harrogate and 1st February 1983 in respect of the remainder of that constituency and the constituency of Keighley), there shall be substituted the constituencies which are named on the left-hand side of Part IV of the Schedule to this Order and comprise the areas set out on the right-hand side, which areas are local government areas as they existed on 23rd January 1986 (and accordingly as altered by the North Yorkshire and West Yorkshire (Areas) Order 1982(d)).

North East Cambridgeshire, South East Cambridgeshire and South West Cambridgeshire

6. For the county constituencies of North East Cambridgeshire, South East Cambridgeshire and South West Cambridgeshire as constituted by the Schedule to the 1983 Order (and described by reference to local government areas as they existed on 5th May 1983 in respect of those parts of the constituencies of North East Cambridgeshire and South East Cambridgeshire which consist of wards of the District of East Cambridgeshire and 1st February 1983 in respect of the remainder of those constituencies and the constituency of South West Cambridgeshire), there shall be substituted the constituencies which are named on the left-hand side of Part V of the Schedule to this Order and comprise the areas set out on the right-hand side, which areas are local government areas as they existed on 23rd January 1986 (and accordingly as altered by the East Cambridgeshire (Parishes) Order 1983(e) and the South Cambridgeshire (Parishes) Order 1984(f)).

7. Each electoral registration officer for the constituencies referred to in Articles 2 to 6 above shall make such re-arrangement or adaptation of the registers of parliamentary electors as may be necessary to give effect to this Order.

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order gives effect without modification to the recommendations contained in the report of the Boundary Commission for England dated 23rd January 1986. The report contains proposals for changes to the areas of certain parliamentary constituencies where local government area changes have resulted in inconsistencies between local government boundaries and the boundaries of parliamentary constituencies. Articles 2 to 6 of, and the Schedule to, this Order set out and describe the new constituencies, the boundaries of which will be consistent with the revised local government boundaries. By virtue of the proviso to section 3(6) of the House of Commons (Redistribution of Seats) Act 1949, the new constituencies will only have effect as from the next parliamentary general election.
