CUSTOMS AND EXCISE

The Customs Duties (ECSC) (No. 2) (Amendment No. 3)
Order 1986*Approved by the House of Commons**Made - - - 8th May 1986**Laid before the
House of Commons - 8th May 1986**Coming into Operation 9th May 1986*

The Treasury, by virtue of the powers conferred on them by section 5(1) and (3) of, and paragraph 4 of Schedule 2 to, the European Communities Act 1972(a) and of all other powers enabling them in that behalf, on the recommendation of the Secretary of State, hereby make the following Order:—

1. This Order may be cited as the Customs Duties (ECSC) (No. 2) (Amendment No. 3) Order 1986 and shall come into operation on 9th May 1986.

2. Up to and including 31st December 1986, Article 6(1) of the Customs Duties (ECSC) (No. 2) Order 1985(b) (which exempts from duty goods to which that Order applies originating in certain countries) shall not apply to goods which fall within headings 73.11A.I, 73.11A.IV(a)1 and 73.11B which originate in Yugoslavia.

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order, which comes into operation on 9th May 1986, amends the Customs Duties (ECSC) (No. 2) Order 1985 ("the main Order") which charges customs duties in accordance with the unified ECSC tariff on certain ECSC products imported into the United Kingdom except from other member States of the European Coal and Steel Community (ECSC) and from certain other countries named in Schedule 1 to the main Order.

This Order reimposes duties on goods falling within headings 73.11.AI, 73.11A.IV.a)1 and 73.11B which originate in Yugoslavia.

This Order implements a reintroduction of duty up to the end of 1986 made pursuant to Article 1, paragraph 3 of a decision 85/522/ECSC of the representatives of the governments of the member States of the European Coal and Steel Community meeting within the Council on 18th November 1985 (OJ No. L327, 6.12.1985, p.35). Decision 85/522/ECSC of 18th November 1985 established ceilings for imports of certain ECSC goods originating in Yugoslavia. These ceilings have now been reached on goods falling within the above headings.

The Commission communication to member States giving notice of the reintroduction of customs duties is published in OJ No. C108, 6.5.86.
