## AGRICULTURAL GRANTS, GOODS AND SERVICES

**The Agricultural and Horticultural Co-operation Grants  
(Extension of Period) Order 1986**
*Laid before the House of Commons in draft*

<i>Made</i> - - - -	7th May 1986
<i>Coming into Operation</i>	15th May 1986

The Minister of Agriculture, Fisheries and Food, the Secretary of State for Scotland and the Secretary of State for Wales, acting jointly, in exercise of the powers conferred by sections 61(6) and 62 of the Agriculture Act 1967 (a) and now vested in them(b), and of all other powers enabling them in that behalf, with the approval of the Treasury, hereby make the following order, a draft whereof has been laid before and approved by resolution of the Commons House of Parliament:—

*Title and commencement*

1. This order may be cited as the Agricultural and Horticultural Co-operation Grants (Extension of Period) Order 1986, and shall come into operation on 15th May 1986.

*Extension of period*

2. The period mentioned in subsection (6) of section 61 of the Agriculture Act 1967 (being the period within which proposals in respect of which grant is payable under that section must be submitted to Food from Britain), having been thrice extended for the additional periods of three years beginning respectively on 15th May 1977, 15th May 1980 and 15th May 1983 (c) is hereby extended for a further additional period of five years beginning on 15th May 1986.

## EXPLANATORY NOTE

*(This Note is not part of the Order.)*

This order further extends, up to 14th May 1991, the period within which applications for grant aid purposes connected with co-operative activities in agriculture may be submitted to the organisation "Food from Britain", to which the functions of the Central Council for Agricultural and Horticultural Co-operation were transferred on the 23rd March 1983. The period would otherwise expire on 14th May 1986. Applications for grant aid purposes are currently made under the Agricultural and Horticultural Co-operation Scheme 1985 (S.I. 1985/334).
