PROBATION

The Combined Probation Areas (Dyfed) Order 1986

Made - - - *6th June 1986*

Coming into Operation *1st July 1986*

In exercise of the powers conferred upon me by section 54(4) of, and paragraph 1 of Schedule 3 to, the Powers of Criminal Courts Act 1973(a) and after the consultation required by that paragraph, I hereby make the following Order:—

1. This Order may be cited as the Combined Probation Areas (Dyfed) Order 1986 and shall come into operation on 1st July 1986.

2. Schedule 2 to the Combined Probation Areas Order 1974(b) shall be amended by substituting for the entry in respect of Dyfed the following entry:—

The four members of the Dyfed Probation Committee appointed by the justices for the petty sessional divisions of Carmarthen, St. Clears and Whitland before those divisions were combined to form a new division known as the Carmarthen South Division, the two members of that Committee appointed by the justices for the petty sessional divisions of Newcastle Emlyn and Pencader

before those divisions were combined to form a new division known as the Carmarthen North division, the three members of that Committee appointed by the justices for the petty sessional divisions of Dewsland Haverfordwest and Milford Haven before those divisions were combined to form a new division known as the Cleddau division, the three members of that Committee appointed by the justices for the petty sessional divisions of Amman Valley, Llandeilo and Llandovery before those divisions were combined to form a new division known as the Dinefwr division, the two members of that Committee appointed by the justices for the petty sessional divisions of Cemaes and Fishguard before those divisions were combined to form a new division known as the Gogledd Preseli division and the three members of that Committee appointed by the justices for the petty sessional divisions of Narberth, Pembroke and Tenby before those divisions were combined to form a new division known as the South Pembrokeshire division shall all continue to hold office as members of that Committee, as if they had been appointed by the justices for the relevant new division, until 30th November 1986 and shall then cease to hold office but shall be eligible for re-appointment.
