Her Majesty, in exercise of the powers conferred on Her by section 2 of the Child Abduction and Custody Act 1985(1), is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

**1.** This Order may be cited as the Child Abduction and Custody (Parties to Conventions) (Amendment) Order 1987.

**2.** The Child Abduction and Custody (Parties to Conventions) Order 1986(**2**) is amended by deleting Schedule 1 thereto and substituting therefor the following—
