**The Food Protection (Emergency Prohibitions) (Wales)(No. 5) Order 1987**

Whereas the Secretary of State is of the opinion, as mentioned in section 1(1)(a) of the Food and Environment Protection Act 1985((1)), that there has been or may have been an escape of substances of such descriptions and in such quantities and such circumstances as are likely to create a hazard to human health through human consumption of food;

And whereas the Secretary of State is of the opinion, as mentioned in section 1(1)(b) of the said Act, that in consequence of the said escape of substances food which is or may be in the future in the areas described in the Schedule to the following Order, or which is derived or may be in the future derived from anything in those areas, is, or may be, or may become, unsuitable for human consumption;

Now, therefore, the Secretary of State, in exercise of the powers conferred on him by the said section 1(1) and (2) and section 24(1) and (3) of the said Act, and of all other powers enabling him in that behalf, hereby makes the following Order:—

**Title, commencement and interpretation**

1.—(1) This Order may be cited as the Food Protection (Emergency Prohibitions) (Wales) (No. 5) Order 1987 and shall come into force on 7th November 1987.

(2) In this Order—

- (a) “the Act” means the Food and Environment Protection Act 1985,
- (b) “designated area” means an area described in the Schedule to this Order,

- (c) “sheep” means an animal of the genus *Ovis* of whatever age or sex.

### **Designated incident**

2. In the opinion of the Secretary of State, food in the areas described in the Schedule to this Order, or which is derived or may be in the future derived from anything in those areas, is, or may be, or may become unsuitable for human consumption in consequence of the following escape of substances:—

the escape on or after 26th April 1986 of radioactive substances from a nuclear powered reactor situated at Chernobyl in the Ukraine, USSR.

### **Designated areas**

3. The areas described in the Schedule to this Order are hereby designated for the purposes of Part I of the Act. Activities prohibited in the designated areas

4.—(1) Subject to paragraph (2) below, no person shall in a designated area slaughter any sheep for human consumption or for use in the preparation of feeding stuffs.

(2) Paragraph (1) above shall not apply in the case of any sheep which—

- (a) was moved from any place in accordance with a consent given under section 2(1) of the Act which consent was subject to the condition that the sheep to which it applies should be marked with a red mark; and
- (b) has been examined and marked by an ear-tag by a person authorised in that behalf by one of the Ministers((2)). Restrictions on movement

5.—(1) No person shall move any sheep from a farm, holding or agricultural premises situated in a designated area.

(2) Subject to paragraph (3) below, no person shall move into a designated area any sheep which has been removed from a designated area or from an area which is from time to time designated by an order other than this Order under section 1 of the Act which refers to the escape of substances described in article 2 of this Order.

(3) Paragraph (2) above shall not apply in the case of any sheep which was moved from any place in accordance with a consent given under section 2(1) of the Act which was subject to the condition that the sheep to which it applies should be marked with a red mark.

### **Restrictions throughout the United Kingdom**

6.—(1) Subject to paragraph (2) below, no person shall, in the United Kingdom—

- (a) slaughter for human consumption or for use in the preparation of feeding stuffs any sheep that was—
  - (i) in any of the areas numbered 1, 2 and 3 of the designated areas detailed in the Schedule to this Order at any time after 11 a.m. on 20th June 1986; or
  - (ii) in the area numbered 4 of the designated areas detailed in the said Schedule at any time after 9th July 1987; or
  - (iii) in any of the areas numbered 5, 6, 7 and 8 of the designated areas detailed in the said Schedule at any time after 10th August 1987; or
  - (iv) in any of the areas numbered 9, 10, 11 and 12 of the designated areas detailed in the said Schedule at any time after 27th August 1987; or

(2) The definition of “the Ministers” is in section 24(1) of the Food and Environment Protection Act 1985.

- (v) in any of the areas numbered 13, 14 and 15 of the designated areas detailed in the said Schedule at any time after 17th September 1987, or
  - (b) supply, or have in possession for supply, any meat derived from a sheep, or any food which contains any such meat, if that sheep was—
    - (i) in any of the areas numbered 1, 2 and 3 of the designated areas detailed in the Schedule to this Order at any time after 11 a.m. on 20th June 1986; or
    - (ii) in the area numbered 4 of the designated areas detailed in the said Schedule at any time after 9th July 1987; or
    - (iii) in any of the areas numbered 5, 6, 7 and 8 of the designated areas detailed in the said Schedule at any time after 10th August 1987; or
    - (iv) in any of the areas numbered 9, 10, 11 and 12 of the designated areas detailed in the said Schedule at any time after 27th August 1987; or
    - (v) in any of the areas numbered 13, 14 and 15 of the designated areas detailed in the said Schedule at any time after 17th September 1987.
  - (2) Paragraph (1) above shall not apply in the case of—
    - (a) any sheep which was moved to a market in accordance with a consent given under section 2(1) of the Act which consent did not require that the sheep to which it applies should be marked in a manner specified therein;
    - (b) any sheep which was moved from any place in accordance with a consent given under the said section 2(1) on or before 21st December 1986 which consent was subject to the condition that the sheep to which it applies should be marked with a blue mark;
    - (c) any sheep which was moved from any place in accordance with a consent given under the said section 2(1) on or before 26th July 1987 which consent was subject to the condition that the sheep to which it applies should be marked with an apricot mark; or
    - (d) any sheep which—
      - (i) was moved from any place in accordance with a consent given under the said section 2(1) which consent was subject to the condition that the sheep to which it applies should be marked with a red mark or with a green mark; or
      - (ii) was moved from any place in accordance with such a consent given on or after 28th September 1987 which consent was subject to the condition that the sheep to which it applies should be marked with a blue mark;
- and which, in either case, has been examined and marked with an ear-tag by a person authorised in that behalf by one of the Ministers.

## Revocation

7. The Food Protection (Emergency Prohibitions) (Wales) (No. 4) Order 1987((3)), the Food Protection (Emergency Prohibitions) (Wales) (No. 4) Amendment Order 1987((4)) and the Food Protection (Emergency Prohibitions) (Wales) (No. 4) Amendment No. 2 Order 1987((5)) are hereby revoked.

## SCHEDULE

Article 3

### DESIGNATED AREAS

1. An area comprising that part of the County of Powys which lies within the following boundary:

From the meeting of the Afon Conwy with the Forestry Commission fence at OS map reference SH 999179 generally north-eastwards following the forest boundary fence to its junction with the farm fence at OS map reference SH 995188 then generally northwards following the farm fence to OS map reference SH 998199 and then generally north-westwards along the forest fence to where it crosses the stream at OS map reference SH 989204 and then generally following the course of the stream to where it joins Llyn Efyrynwy near the waterfall at OS map reference SH 995206 and then crossing Llyn Efyrynwy in a generally north-westwards direction to the forest boundary at OS map reference SH 988217 and then following the forestry boundary to its junction with the stream at OS map reference SH 993225 and then generally eastwards following the course of the stream through the forest to its junction with the stream at OS map reference SH 999222 and then generally north-eastwards following the course of the stream to where it meets the forestry boundary at OS map reference SJ 003224 and then generally north-eastwards following the forest boundary to where it joins the fenced Nant Coedwyr Boundary at OS map reference SJ 003226 and then generally north-eastwards, following the fenced Nant Coedwyr Boundary to where it joins the Severn-Trent Boundary at OS map reference SJ 013240 and then generally north-westwards along the Severn-Trent Boundary passing through OS map references SJ 004244 and SJ 003260 to where it joins the fence at the County Boundary at OS map reference SH 990280 at Cynriau Nod; then westwards and then south-westwards along the fence following the County Boundary passing through OS map references SH 946270 and SH 916229; then generally southwards along the fence to the Severn-Trent Water Authority fence at OS map reference SH 928202 and thereafter as a Forestry Commission fence to a point near Drum Ddu at OS map reference SH 932166; then continuing generally eastwards along the Forestry Commission fence to where it meets a Forestry Commission fence along a footpath at OS map reference SH 975168; generally northwards following the fence along the footpath to where it meets a Forestry Commission fence at OS map reference SH 972177; generally south-eastwards then north-eastwards along the fence to where it meets the Afon Conwy at OS map reference SH 999179.

The area excludes any part of a road, footpath or body of water by reference to which its boundary is defined.

2. An area comprising that part of the County of Gwynedd which lies within the following boundary:—

750347; following the line of the fence south-eastwards to Afon Gain at OS map reference SH 756339; following the course of the Afon Gain generally southwards to the forest fence at OS map reference SH 755336; following the fence southwards to Pont y Gain at OS map reference SH 752328 then following the Afon Gain to where it meets an unmarked road near Pont-y-Llyn-du at OS map reference SH 731306; generally north-westwards along the unmarked road until it meets the A470(T) at OS map reference SH 711349, generally southwards along the A470(T) passing through OS map references SH 712318, SH 714301 and SH 715291 until it meets a fence and public footpath at OS map reference SH 715287 near Gelli-goch; along the public footpath in a generally north-westwards direction to a ford at the confluence of the Afon Eden and Afon Crawcwellt at OS map reference SH 712290; westwards along the course of the Afon Crawcwellt to where it meets a fence at a ford at OS map reference SH 693289; generally south-westwards along the fence which forms the eastern boundary to the forest known as Coed y Brenin Forest to OS map reference SH 679278; along the forest boundary fence in a north-westwards direction to OS map reference SH 672286, then continuing in a south-westwards direction to the junction with a path at OS map reference SH 670288; following the path in a south-westwards direction to the fence at OS map reference SH 665282; along the fence in a generally south-westwards direction passing through OS map references SH 658280 and SH 644269, to where the fence meets the Afon Cwmnantcol at OS map reference SH 637263; along the course of the Afon Cwmnantcol in a generally west-north-westwards direction passing through OS map references SH 625267, SH 615569 and SH 610265 to the reservoir at OS map reference SH 604269; along the northern edge of the reservoir to the dam at OS map reference SH 603269 and continuing along the Afon Cwmnantcol to where it meets with an unmarked road at OS map reference SH 600274; along the road in a north-eastwards direction to its junction with another unmarked road near Werngron at OS map reference SH 609283; north-westwards along this road passing by Maesyraelfor and Cefnfilltir to its junction with the B4573, also known as Stryd Fawr, Harlech at OS map reference SH 582311; along the B4573 in a generally north-eastwards direction to the junction with the A496 at OS map reference SH 606349; along the A496 in a north-eastwards direction to the junction with the Afon Prysor at Pont Felinrhyd-fawr at OS map reference SH 653396; along the course of the Afon Prysor in a south-eastwards direction until it meets Llyn Trawsfynydd at OS map reference SH 674377; following the south-western boundary of the lake passing through OS map references SH 689359 and SH 701349 until it meets the Afon Prysor at OS map reference SH 708349 then following the Afon Prysor in a north-eastwards direction passing through OS map references SH 711350 and SH 727352 to where it meets with Nant Budr at OS map reference SH 737360.

From the junction of the A5(T) with an unmarked road near Ty Hyll at OS map reference SH 756575; generally westwards along the unmarked road to where it meets a fence at OS map reference SH 754575; generally southwards along the fence to OS map reference SH 754570 then westwards along the fence to where it meets a stream at OS map reference SH 752570; generally southwards along the fence through OS map references SH 752569, SH 752565 and SH 752561; generally south-eastwards to OS map reference SH 754555; generally south-westwards through OS map references SH 750551 and SH 743548 to its junction with Afon Ystumiau at OS map reference SH 741547; generally westwards along the course of Afon Ystumiau to its junction with the fence at OS map reference SH 738546; generally north-westwards to its junction with the forest fence at OS map reference SH 737547; generally westwards along the forest fence to OS map reference SH 736546; generally north-westwards to OS map reference SH 733548; northwards to OS map reference SH 733550; generally north-



eastwards through OS map references SH 737557 and SH 740560 to OS map reference SH 743567; in a generally anti-clockwise direction around the forest to the unmarked road at OS map reference SH 743568; along the unmarked road to the junction of the A5(T) with an unmarked road near Ty Hyll at OS map reference SH 756575.

The area excludes any part of a road, footpath or body of water by reference to which its boundary is defined.

**15.** An area comprising that part of the County of Gwynedd which lies within the following boundary:—

From the forest fence at OS map reference SH 802496 generally north-westwards along the forest fence to the junction with an unmarked road at OS map reference SH 798497 then north-westwards along the unmarked road to the junction with another unmarked road at OS map reference SH 795502; then northwards along the road to the junction with the B4406 at OS map reference SH 795551; then north-eastwards along the B4406 to where it meets with Nant Caddugen at OS map reference SH 800518; following the course of the Nant Caddugen in a generally south-eastwards direction to where it meets with the Nant y Parc at OS map reference SH 808513; then southwards following the course of the Nant y Parc to where it meets with a fence at the confluence of the Nant y Parc with the Nant Ffridd Wen at OS map reference SH 806510 then generally southwards along the fence to where it meets with a track at SH 802496.

The area excludes any part of a road, footpath or body of water by reference to which its boundary is defined.

## EXPLANATORY NOTE

*(This note is not part of the Order)*

This Order revokes and re-enacts without modification the Food Protection (Emergency Prohibitions) (Wales) (No. 4) Order 1987 as amended by S.I.1987/1682 and /1802. It contains emergency prohibitions restricting various activities in order to prevent human consumption of food which has been or which may have been rendered unsuitable for that purpose in consequence of the escape of radioactive substances from a nuclear reactor situated at Chernobyl in the USSR.

The Order designates areas of land in Wales affected by the escape from which the movement of sheep, and in which the slaughter of sheep, are prohibited (articles 3, 4, 5(1) and the Schedule). The prohibition on slaughter in the designated areas does not apply to any sheep identified by a red paint mark which have been examined and subsequently marked by an ear-tag by a person authorised by the Minister of Agriculture, Fisheries and Food, the Secretary of State for Scotland, the Secretary of State for Wales or the Department of Agriculture for Northern Ireland (article 4(2)). Movement into a designated area of sheep which have been removed from it or from a similarly designated area elsewhere in the United Kingdom (other than sheep which have been identified by a red paint mark, and moved, in accordance with a Ministerial consent) is prohibited (article 5(2)).

Restrictions on the slaughter of sheep which were—

- (a) in any of the designated areas numbered 1, 2 and 3 in the Schedule after 11 a.m. on 20th June 1986;
- (b) in the designated area numbered 4 in the Schedule after 9th July 1987;

*Status: This is the original version (as it was originally made). This item of legislation is currently only available in its original format.*

- (c) in any of the designated areas numbered 5, 6, 7 and 8 in the Schedule after 10th August 1987;
- (d) in any of the designated areas numbered 9, 10, 11 and 12 in the Schedule after 27th August 1987; and
- (e) in any of the designated areas numbered 13, 14 and 15 in the Schedule after 17th September 1987,

and the supply of meat derived from such sheep, extend throughout the United Kingdom (article 6(1)). This order replaces restrictions which—

- (a) as regards the areas mentioned in (a) above have been in force since 11 a.m. on 20th June 1986,
- (b) as regards the area mentioned in (b) above have been in force since 10th July 1987,
- (c) as regards the areas mentioned in (c) above have been in force since 11th August 1987,
- (d) as regards the areas mentioned in (d) above have been in force since 28th August 1987, and
- (e) as regards the areas mentioned in (e) above have been in force since 18th September 1987.

The said restrictions on slaughter and supply imposed by article 6(1) shall not apply to any sheep—

- (a) which has been moved unmarked to a market in accordance with a Ministerial consent;
- (b) identified by a blue paint mark and which has been moved in accordance with a Ministerial consent given on or before 21st December 1986;
- (c) identified by an apricot paint mark and which has been moved in accordance with a Ministerial consent given on or before 26th July 1987; or
- (d) identified by a red, green or blue paint mark which has been examined and subsequently marked with an ear-tag by a person authorised by the Minister of Agriculture, Fisheries and Food, the Secretary of State for Scotland, the Secretary of State for Wales or the Department of Agriculture for Northern Ireland and which has been moved in accordance with a Ministerial consent, in the case of sheep identified by a blue paint mark only if such a consent has been given on or after 28th September 1987 (article 6(2)).

Under Section 21 of the Food and Environment Protection Act 1985 the penalty for contravening an emergency prohibition is—

- (a) on summary conviction, a fine of an amount not exceeding the statutory maximum (at present £2,000);
- (b) on conviction on indictment, an unlimited fine, or imprisonment for a term of not more than two years or both.

Powers of enforcement in relation to emergency prohibitions are conferred by section 4 of, and Schedule 2 to, the 1985 Act. Obstruction of enforcement officers is an offence under paragraph 10 of that Schedule.
