PENSIONS

The Personal Injuries (Civilians) Amendment Scheme 1987

Made - - - - *11th February 1987*
Laid before Parliament *18th February 1987*
Coming into force - - *6th April 1987*

The Secretary of State for Social Services, with the consent of the Treasury, in exercise of the powers conferred by sections 1 and 2 of the Personal Injuries (Emergency Provisions) Act 1939(1) and now vested in him(2), and of all other powers enabling him in that behalf, hereby makes the following Scheme:-

Citation, commencement and interpretation

1.—(1) This Scheme may be cited as the Personal Injuries (Civilians) Amendment Scheme 1987 and shall come into force on 6th April 1987.

(2) In this Scheme the expression “the principal Scheme” means the Personal Injuries (Civilians) Scheme 1983(3).

Amendment of Article 18 of the principal Scheme

2. In Article 18 of the principal Scheme (unemployability allowances) in paragraph (2) for the amount “£1,326” there shall be substituted the amount “£1,352”.

Abolition of funeral grants

3.—(1) The principal Scheme shall be amended in accordance with the following provisions of this Article.

(2) Article 40 (funeral grants), and paragraph 12 of Schedule 4 are hereby revoked.

(3) In Article 53 the words “(other than a funeral grant)” and the words “and the expression “funeral grant” means a funeral grant under Article 40” shall be omitted.

(4) In Article 54(3) the words “or of a funeral grant” shall be omitted.

- (8) In Article 67(1) and (2) the words “or funeral grant” shall be omitted wherever they appear.
- (9) In Article 79 the words “or funeral grant” shall be omitted wherever they appear.

Substitution of Schedules 3 and 4 to the principal Scheme

4. For Schedules 3 and 4 to the principal Scheme (rates of pensions and allowances payable in respect of disablement and death) there shall respectively be substituted the Schedules set out in the Schedule hereto and numbered 3 and 4.

EXPLANATORY NOTE

(This note is not part of the Scheme)

This Scheme, which takes effect from 6th April 1987, further amends the Personal Injuries (Civilians) Scheme 1983 (“the principal Scheme”) which makes provision for the payment of pensions and allowances to or in respect of civilians who were killed or injured in the 1939—45 War. Article 40 of the principal Scheme (funeral grants) is revoked to accord with the abolition of death grant payable under section 32 of the Social Security Act 1975 (c. 14) by the Social Security Act 1986 (c. 50), section 41 (Article 3).

This Scheme also raises the maximum amount of annual earnings which may be received by a disabled person while he is deemed to be unemployable for the purposes of unemployability allowances under Article 18 of the principal Scheme, and varies the rates of pensions and allowances in respect of disablement and death in the 1939-45 War (Articles 2 and 4, and the Schedule).
