The Local Land Charges (Amendment) Rules 1987

<i>Made - - - -</i>	<i>9th March 1987</i>
<i>Laid before Parliament</i>	<i>11th March 1987</i>
<i>Coming into force</i>	<i>1st April 1987</i>

The Lord Chancellor, in exercise of the powers conferred on him by section 14 of the Local Land Charges Act 1975(a) and with the concurrence of the Treasury as to fees, hereby makes the following Rules:

1. These Rules may be cited as the Local Land Charges (Amendment) Rules 1987 and shall come into force on 1st April 1987.
2. For Schedule 3 to the Local Land Charges Rules 1977(b) there shall be substituted the following Schedule:

3. The Local Land Charges (Amendment) Rules 1986(a) are hereby revoked.
