REPRESENTATION OF THE PEOPLE

The Returning Officers' Expenses Regulations 1987

 Made
 13th May 1987

 Coming into force
 20th May 1987

The Treasury, in exercise of the powers conferred on them by section 29(3) of the Representation of the People Act 1983(1), hereby make the following Regulations:—

- **1.** These Regulations may be cited as the Returning Officers' Expenses Regulations 1987 and shall come into force on 20th May 1987.
- **2.** The maximum charges to which a returning officer at a parliamentary election in England, Wales and Scotland shall be entitled are:—
 - (a) in respect of services rendered by him, the amounts specified in Part A of the Schedule to these Regulations; and
 - (b) in respect of expenses incurred by him, the amounts specified in Part B of the said Schedule.
- **3.** The Returning Officers' Expenses (England and Wales) Regulations 1984(**2**) and the Returning Officers' Expenses (Scotland) Regulations 1984(**3**) are hereby revoked.

SCHEDULE

SCALE OF MAXIMUM CHARGES IN RESPECT OF SERVICES RENDERED AND EXPENSES INCURRED BY A RETURNING OFFICER FOR THE PURPOSES OF OR IN CONNECTION WITH A PARLIAMENTARY ELECTION

Only the fees and disbursements specified hereunder shall be chargeable and in particular a returning officer shall not be entitled to charge as an expense payments which he makes from his fees (or otherwise) to a deputy acting returning officer or deputy returning officer by way of remuneration for performing functions of the returning officer.

2. For services in connection with the despatch and receipt of the ballot papers of persons entitled to vote by post:

PART B—DISBURSEMENTS

Except as expressly provided in this part of the Schedule, in no case shall a charge exceed the sum actually and necessarily paid or payable by the returning officer. Subject thereto the maximum charges shall be as follows:

In a contested election:

1. For the presiding officer at each polling 65.00 station (to include all expenses, other than any travelling and overnight subsistence expenses specified in this part of the Schedule)

In addition, a further sum, not exceeding £4.26 may be paid to one of the presiding officers at a polling place to which there are assigned not less than 3,000 entries in the register of electors to be used at the election (as first published), being a presiding officer who acts as overall presiding officer at that polling place.

- (a) (a) For one clerk at each polling 41.64 station
- (b) (b) For additional clerks at a polling station to which there are assigned more than 700 entries in the register of electors to be used at the election (as first published) such additional clerks not to exceed one clerk for every 600 entries or fraction thereof in excess of 700:

For each additional clerk (whole-time or parttime as the case may require) an amount within a range having a maximum of

- (1) For the employment of persons in connection with the manual preparation and issue of the official poll cards, including charges for superannuation contributions where payable:
 - (a) (a) For the initial preparation of the cards:

For every 100 cards or fraction thereof 2.81

- (b) (b) For each revision:
- (i) For every 100 cards or fraction thereof 0.46 prepared on initial preparation
- (ii) For every 100 new cards or fraction thereof 2.81 prepared

Provided that, if the number of new cards does not exceed 15 per cent of the number prepared on the initial preparation, the total allowance, for the revision shall be increased by 5 per cent.

(c) (c) For the revision of a particular 2.81 section of the cards (other than such a revision carried out in the course of a revision of the whole):

For every 100 new cards or fraction thereof prepared

(d) (d) For the completion and issue of the cards on the occasion of an election:

For every 100 cards or fraction thereof 1.45 issued (or withdrawn in respect of votors entitled to vote by post)

(2) For the employment of persons in connection with the issue of poll cards which have not been prepared manually, including charges for superannuation contributions where payable:

For every 100 cards or fraction thereof 0.92

Provided that the maximum amount which a returning officer shall be entitled to charge under this paragraph shall be the total of the sums which he would be entitled to charge for such of the stages of work represented by items (1)(a), (b), (c) and (d) and (2) hereunder as he has carried out, notwithstanding that the amount disbursed by him for any particular stage is greater than the amount specified hereunder as the maximum amount for that stage; provided also that the maximum amount which a returning officer shall be entitled to charge under this paragraph shall be increased by any amount by which the maximum amount which he is entitled to charge under paragraph 4 below exceeds the amount disbursed by him for the purposes described in that paragraph.

- **4.** For the employment of persons in connection with the count and the ballot papers of electors entitled to vote by post, and for all clerical and other assistance employed by the returning officer, deputy returning officer, acting returning officer or deputy acting returning officer for the purposes of the election, including charges for day subsistence expenses and for superannuation contributions where payable.
 - (a) (a) If the number of entries in 2,305.75 the register of electors to be used at the election (as first published) in the constituency does not exceed 50,000

For every additional 1,000 entries or fraction thereof over 50,000

Provided that the maximum amount which a returning officer shall be entitled to charge under this paragraph shall be increased by any amount by which the maximum amount which he is entitled to charge under paragraph 3 above exceeds the amount disbursed by him for the purposes described in that paragraph.

Returning officer's, deputy returning Actual and necessary cost. officer's, acting returning officer's or deputy acting returning officer's travelling and overnight subsistence expenses where necessary to make arrangements for the poll or otherwise in connection with the conduct of the election.

6. Travelling and overnight subsistence Actual and necessary cost. expenses of presiding officers and poll clerks (including any expenses incurred in conveying the ballot boxes in those cases in which presiding officers or poll clerks are responsible for the transport of the boxes to or from the polling stations).

7. Travelling and overnight subsistence Actual and necessary cost. expenses of clerical and other assistants employed by the returning officer, deputy returning officer, acting returning officer or deputy acting returning officer where necessary to make arrangements for the poll or otherwise in connection with the conduct of the election.

- 8. For printing and providing actual ballot Actual and necessary cost. papers
- 9. For printing and providing official poll Actual and necessary cost. cards
- 10. For printing and providing notices and Actual and necessary cost. other documents required in and about the election or poll and costs of publishing the same.

11. For the renting of any building or room Actual and necessary cost. for the purpose of the election and for expenses of heating, lighting and cleaning any building or room for such purpose.

12. For adapting and fitting up any building Actual and necessary cost or room for the purpose of the election (including the provision of voting compartments and any

necessary furniture) and restoring it to fit condition for its normal use.

- **13.** For providing ballot boxes, including any Actual and necessary cost. repairs
- 14. For the conveyance of ballot boxes and Actual and necessary cost. ballot papers in those cases where the cost of transport is not included in the travelling expenses of presiding officers and poll clerks under paragraph 1.6 of this part of the Schedule.
- **15.** For every stamping instrument required Actual and necessary cost. to be purchased, hired, altered or repaired.
 - **16.** For copies of the register

Actual and necessary cost.

17. For general stationery, postage, telephone Actual and necessary cost. calls, bank charges and miscellaneous expenses.

In an uncontested election, for all necessary preliminary work the amount shall be the same as the amount specified for corresponding work in a contested election, except that for all clerical and other assistance employed by the returning officer, deputy returning officer, acting returning officer or deputy acting returning officer for the purposes of the election, including charges for day subsistence expenses and for superannuation contributions where payable, the amount shall not be more than one-quarter of the amount specified under paragraph 1.4 of this part of the Schedule.

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations revoke and replace the Returning Officers' Expenses (England and Wales) Regulations 1984 and the Returning Officers' Expenses (Scotland) Regulations 1984. They prescribe, in relation to England, Wales and Scotland, a revised scale further increasing the maximum fees in respect of services rendered and the maximum charges in respect of expenses incurred by a returning officer for the purposes of or in connection with a parliamentary election. Separate charges are prescribed in respect of the preparation of poll cards by manual and by non-manual means. The increases over those prescribed in 1984 are between 14 per cent and 18"half" per cent save that the maximum charge prescribed for the presiding officer is increased by 30 per cent.
