The Submarine Pipe-lines (Designated Owners) (No. 14) Order 1988

- **1.** This Order may be cited as the Submarine Pipe-lines (Designated Owners) (No. 14) Order 1988 and shall come into force on 1st August 1988.

EXPLANATORY NOTE

This Order designates the companies listed in Part I of the Schedule as owners of the pipe-lines described in Part II of the Schedule. The pipe-lines lie above the Buchan oilfield, situated north-east of Peterhead, and between that oilfield and the Forties oilfield.
