CHANGES IN LOCAL GOVERNMENT AREAS

The Tayside, Fife and Central Regions and Perth and Kinross, Dunfermline and Clackmannan Districts (Solsgirth) Boundaries Amendment Order 1988

Made	29th February 1988
Laid before Parliament	10th March 1988
Coming into force	1st April 1988

Whereas under section 17(1) of the Local Government (Scotland) Act 1973((1)) the Local Government Boundary Commission for Scotland on 24th November 1987 submitted to the Secretary of State a report on a review conducted under section 14(2) of that Act in which they made proposals for the transfer of certain areas from Perth and Kinross District in Tayside Region and Dunfermline District in Fife Region to Clackmannan District in Central Region and in which they also made proposals for changes in electoral arrangements consequential on those changes in local government areas;

Now, therefore, in exercise of the powers conferred on him by section 17(2) of the said Act, and of all other powers enabling him in that behalf, the Secretary of State hereby makes the following Order to give effect to the proposals of the Local Government Boundary Commission for Scotland as submitted to him:

Title and commencement

1. This Order may be cited as the Tayside, Fife and Central Regions and Perth and Kinross, Dunfermline and Clackmannan Districts (Solsgirth) Boundaries Amendment Order 1988, and shall come into force on 1st April 1988.

Interpretation

2. In this Order—

"the 1977 Regulations" means the Local Government Area Changes (Scotland) Regulations 1977((2)); and

"boundary map" means the map prepared by the Scottish Office, marked "The Tayside, Fife and Central Regions and Perth and Kinross, Dunfermline and Clackmannan Districts (Solsgirth) Boundaries Amendment Order 1988 Map" and deposited in accordance with regulation 3 of the 1977 Regulations;

and, in the Schedule to this Order, any reference to a boundary of a region is a reference to a boundary existing immediately before the commencement of this Order.

Application of Regulations

3. Save insofar as they can have no application in relation to the area changes effected by this Order, the provisions of the 1977 Regulations shall apply in relation thereto for the purposes of, or in consequence of, this Order.

Area changes

4.—(1) Part of Perth and Kinross District in Tayside Region, being the Area A described in the Schedule to this Order and shown delineated, hatched and marked "Area A" on the boundary map, shall be transferred to Clackmannan District in Central Region.

(2) Part of Dunfermline District in Fife Region, being the Area B described in the Schedule to this Order and shown delineated, hatched and marked "Area B" on the boundary map, shall be transferred to Clackmannan District in Central Region.

Consequential changes of electoral arrangements

5.—(1) Area A described in the Schedule to this Order (being the area transferred by article 4(1) of this Order)—

- (a) shall cease to form part of electoral division 46 (Kinross) of Tayside Region((3)) and of ward 28 (West Kinross) of Perth and Kinross District((4)); and
- (b) shall form part of electoral division 2 (Forthbank) of Central Region((5)) and of ward 4 (Clackmannan) of Clackmannan District((6)).

(2) Area B described in the Schedule to this Order (being the area transferred by article 4(2) of this Order)—

- (a) shall cease to form part of electoral division 30 (Dunfermline Linburn) of Fife Region((7)) and of ward 4 (Saline Oakley) of Dunfermline District((8)); and
- (b) shall form part of electoral division 2 (Forthbank) of Central Region and of ward 4 (Clackmannan) of Clackmannan District.

SCHEDULE

Articles 2, 4 and 5

Area A

The area bounded by a line commencing at a point on the Central/Tayside regional boundary grid reference NS 9819 9463, northeastwards then southeastwards by boundary fence to a point on the Tayside/Fife regional boundary grid reference NS 9854 9458, then southwestwards along that regional boundary to a point grid reference NS 9842 9445, then northwestwards along the existing Central/Tayside regional boundary to the point of commencement.

Area B

The area bounded by a line commencing at a point on the Tayside/Fife regional boundary grid reference NS 9854 9458, then eastwards along that regional boundary to a point grid reference NS 9889 9453, then southwards and westwards along boundary fence and field boundary to a point on the Fife/Central regional boundary grid reference NS 9849 9431, then generally northwestwards along that regional boundary to a point grid reference NS 9842 9445, then northeastwards along the Tayside/Fife regional boundary to the point of commencement.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order transfers areas extending to apporixmately 8 acres and 23 acres at Solsgirth from Perth and Kinross District in Tayside Region and Dunfermline District in Fife Region respectively to Clackmannan District in Central Region and makes consequential changes to electoral arrangements.

The map annexed to and forming part of this note gives a general guide to the areas affected by this Order as from 1st April 1988.
