- 1. This Order may be cited as the Submarine Pipe-lines (Designated Owners) (No. 7) Order 1988 and shall come into force on 1st June 1988.
- **2.** For the purposes of Part III of the Act, each person specified in Part I of the Schedule hereto is hereby designated as the owner of each pipe-line described in Part II of the Schedule.
