# 1989 No. 1018 (S.98) SHERIFF COURT, SCOTLAND

## Act of Sederunt (Fees of Sheriff Officers) 1989

Made - - - - 15th June 1989
Laid before Parliament 26th June 1989
Coming into force - 17th July 1989

The Lords of Council and Session, under and by virtue of the powers conferred on them by section 40 of the Sheriff Courts (Scotland) Act 1907(1), section 6 of the Execution of Diligence (Scotland) Act 1926(2), and of all other powers enabling them in that behalf, do hereby enact and declare:—

#### Citation and commencement

- 1.—(1) This Act of Sederunt may be cited as the Act of Sederunt (Fees of Sheriff Officers) 1989 and shall come into force on 17th July 1989.
  - (2) This Act of Sederunt shall be inserted in the Books of Sederunt.

#### Amendment of fees

2. In Parts I and II of the Schedule to the Act of Sederunt (Fees of Sheriff Officers) 1978(3) in the paragraphs specified in column 1 of the following table, for the fees specified in column 2 substitute the fees specified in column 3 of the table, and the fees so substituted shall be payable in respect of work done on or after the date on which this Act of Sederunt comes into force.
