**The Lotteries (Variation of Monetary
Limits) (Scotland) Order 1989**

The Secretary of State, in exercise of the powers conferred on him by sections 18(1)(b) and 24(2) of the Lotteries and Amusements Act 1976⁽¹⁾ and of all other powers enabling him in that behalf, hereby makes the following Order:

1.—(1) This Order may be cited as the Lotteries (Variation of Monetary Limits) (Scotland) Order 1989 and shall come into force on 1st September 1989.

(2) This Order extends to Scotland only.

2. In the provisions of the Lotteries and Amusements Act 1976 specified in column 1 of the Schedule to this Order (which relate to the matters mentioned in column 2 of that Schedule), for the monetary limits specified in those provisions and set out in column 3 of that Schedule (which limits were substituted by the Orders mentioned in article 3 below) there shall be substituted the monetary limits specified in column 4 of that Schedule.

3.—(1) In the Schedule to the Lotteries (Variation of Monetary Limits) (Scotland) Order 1981⁽²⁾, the entry relating to section 11(2) of the Lotteries and Amusements Act 1976 shall be omitted.

(2) The Lotteries (Variation of Monetary Limits) (Scotland) Order 1985⁽³⁾ is hereby revoked.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order increases the monetary limits specified in the provisions of the Lotteries and Amusements Act 1976 which are mentioned in the Schedule to the Order. The monetary limits have effect under the rules governing lotteries promoted on behalf of societies registered under Part I of Schedule 1 to the 1976 Act and lotteries promoted by local authorities under that Act.
