The Queen's Most Excellent Majesty in Council

Her Majesty, in exercise of the powers conferred on Her by section 2 of the Child Abduction and Custody Act 1985(1), is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

- 1.—(1) This Order may be cited as the Child Abduction and Custody (Parties to Conventions) (Amendment) (No. 3) Order 1989.
- (2) The Child Abduction and Custody (Parties to Conventions) (Amendment) Order 1989(2) is revoked.
- **2.** The Child Abduction and Custody (Parties to Conventions) Order 1986(3) is amended by deleting Schedule 1 thereto(4) and substituting therefor the following—
