## **LAND CHARGES**

# The Local Land Charges (Amendment) Rules 1989

Made -7th June 1989 Laid before Parliament 8th June 1989 Coming into force 1st July 1989

The Lord Chancellor, in exercise of the powers conferred on him by section 14 of the Local Land Charges Act 1975(a) and with the concurrence of the Treasury as to fees, hereby makes the following Rules:

- 1. These Rules may be cited as the Local Land Charges (Amendment) Rules 1989 and shall come into force on 1st July 1989.
- 2. For Schedule 3 to the Local Land Charges Rules 1977(b) there shall be substituted the following Schedule:
