INHERITANCE TAX

The Inheritance Tax (Delivery of Accounts) (Northern Ireland) Regulations 1990

Made - - - - 21st May 1990
Laid before the House of

Coming into force - - 1st July 1990

The Commissioners of Inland Revenue, in exercise of the powers conferred on them by section 256(1) of the Inheritance Tax Act 1984(1), hereby make the following Regulations:

Citation, commencement and extent

- **1.** These Regulations may be cited as the Inheritance Tax (Delivery of Accounts) (Northern Ireland) Regulations 1990 and shall come into force on 1st July 1990.
 - **2.** These Regulations extend to Northern Ireland only.

Interpretation

3. In these Regulations "the Principal Regulations" means the Capital Transfer Tax (Delivery of Accounts) (Northern Ireland) Regulations 1981(2).

Amendments to Principal Regulations

- **4.** In Regulation 3 of the Principal Regulations—
 - (a) in paragraph (b) for "£100,000" there shall be substituted "£115,000";
 - (b) in paragraph (d) for "1st April 1989" there shall be substituted "1st April 1990".

EXPLANATORY NOTE

(This note is not part of the Regulations)

The Principal Regulations (S.I.1981/1441) as amended by the Inheritance Tax (Delivery of Accounts) (Northern Ireland) Regulations 1989 (S.I. 1989/1080) dispensed with the need to deliver an account for the purposes of inheritance tax where (subject to specified exceptions) the value of a deceased's estate did not exceed £100,000 and where the deceased died on or after 1st April 1989. These Regulations increase that limit to £115,000 in respect of deaths on or after 1st April 1990.
